Export Control Working Group 3:00 – 5:00 p.m. Mike Gold, Chair

After more than a decade of struggle and failed efforts, we are on the verge of commercial space-related export control reform legislation being adopted by Congress as part of the FY 2013 National Defense Authorization Act ("NDAA"). During our upcoming meeting on Tuesday, October 9th, at 3 pm, the Export Controls Working Group ("ECWG") will explore the nature of the changes that are likely to be made via the NDAA, how existing legislative language may be improved, and what the export control reform landscape will look like moving forward. We will begin with a panel discussion comprised of officials who are working on this issue in real-time and will provide the Working Group with perspectives from the Obama Administration, Congress, and industry. Specifically, we will be hearing from:

Eric Hirschhorn, Under Secretary, U.S. Commerce Department Bureau of Industry and Security (confirmed) Tom Moore, Senior Professional Staff Member, Senate Foreign Relations Committee (confirmed) David Fite, Senior Professional Staff Member, House Foreign Affairs Committee (invited) Patricia Cooper, President, Satellite Industry Association (confirmed)

After remarks and a Q&A with these speakers, a discussion of potential findings by the ECWG will follow. Again, the officials who will be addressing the COMSTAC are currently working on export control reform
