## **Entry/Exit Requirements**

Entry and exit requirements are for aircraft departing the United States non-stop to country of destination. These requirements do not include any technical stops. Please refer to **Technical Stop** section in **Additional Flight Information** for the country at which the technical stop will be made.

Entry and Exit documentation forms vary from country to country. In general, however, ICAO member countries will accept the following standard ICAO Annex 9 Entry/Exit documents:

- → General Declaration
- → Passenger Manifest
- → Cargo Manifest
- → Embarkation/Disembarkation Card
- → Certificate of Residual Disinsection

## **Entry Requirements (Departing the U.S.)**

- → File an eAPIS manifest outbound (recommend inbound at this time, too)
- → File and activate international flight plan
- → Land at a designated airport of entry (AOE) customs and immigration

The following entry documents are required:

## Passengers -

- → Valid passport
- → <u>Visa</u> for some countries (not required for USA You must have a valid passport and an onward/return ticket for tourist/business "visa free" stays of up to 90 days)
- → Customs Declaration (2 copies)

### Pilots – Same as passengers

*Note*: Holder of Crew member certificate" and "License" will not require any visa for Japan when they leave by the same aircraft or by the next regularly scheduled flight.

*Note:* Other pilot/crewmember requirements may be applicable in lieu of those stated. Contact appropriate AIS for further clarification prior to flight.

Aircraft - No documents are specifically mentioned

### **Exit Requirements (Departing Japan)**

- → Depart from an AOE
- → File eAPIS manifest if inbound to the U.S.
- → File an international flight plan
- → Call U.S. Customs at filed U.S. airport of entry

## Additional Flight Information

### Aircraft Instruments and Equipment

U.S. airworthiness and certification requirements may not meet other country requirements. It is the responsibility of the pilot to determine if the aircraft meets those requirements.

The items listed below are for the pilot's reference to determine if the aircraft meets the minimum instrument and equipment requirements of the destination country. Additional equipment may be required to comply with the airspace navigation requirements.

- 1) Gyroscopic bank and pitch indicator
- 2) Gyroscopic direction finder
- 3) Gyroscopic rate-of-turn indicator
- 4) Slip-skid indicator
- 5) Sensitive altimeter
- 6) Vertical speed indicator
- 7) Airspeed indicating system with heated pilot tube
- 8) Free air temperature indicator
- 9) Sweep-second hand clock
- 10) Airborne DME or
- 11) ADF, VOR receiver, airborne TACAN equipment appropriate to the routes to be flown

- 12) Radio Telephone
- 13) Mode C Transponder

Note: An ADF, a VOR receiver and an airborne TACAN equipment need not be equipped during RNAV operation in defined portions of airspace or on routes where an RNP type has been prescribed.

### Category II operation

- 1) Two ILS Localizer and Glide Slope Receivers
- 2) A Marker Beacon Receiver.
- 3) Two Independent Flight Director Systems with Missed Approach Attitude Guidance; or A Single Flight Director with Missed Approach Attitude Guidance which has Dual Displays and An Auto Pilot System
- 4) An Instrument of displaying the Failure Warning System in ILS Approach
- 5) An Automatic Throttle System or An Automatic Thrust Control System or An Autopilot System
- 6) A Radio Altimeter when IM unserviceable.

## Category IIIA operation

- 1) Two ILS Localizer and Glide Slope Receivers
- 2) Two Radio Altimeters
- 3) A Missed Approach Guidance
- 4) An Automatic Throttle System or An Automatic Thrust Control System
- 5) A Fail-Passive Automatic Landing System and A Warning System detecting a failure of the system; or A Fail-Operational Automatic Landing System and A Warning System detecting a failure of the system.

### Category IIIB operation

- 1) Two ILS Localizer and Glide Slope Receivers
- 2) Two Radio Altimeters
- 3) A Missed Approach Guidance
- 4) An Automatic Throttle System or An Automatic Thrust Control System
- 5) A Fail-Operational Automatic Landing System and A Warning System detecting a failure of the system.
- 6) A Fail-Passive Automatic Rollout Control System; or A Fail-Operational Automatic Rollout Control System
- 7) A Warning System detecting abnormal lateral or vertical deviations during an approach or flare or extended flare beyond the touchdown zone, or excessive lateral deviations during rollout.
- 8) A Deceleration System which has means to assess Stopping Performance; or An Automatic Braking System

#### **RVSM**

## **Technical Stop / Overflight**

### Commercial Operators -

An aircraft desiring to make a non-scheduled commercial flight in transit over or with non-traffic stops in the territory of Japan need not obtain permission for such a flight, provided that it will follow the airway designated by the Minister of Land, Infrastructure, Transport and Tourism. Those that do not follow the airway designated by the Minister of Land, Infrastructure, Transport and Tourism must submit an application for permission 10 days prior of the intended flight.

## Private Flights -

No need to obtain permission to carry out noncommercial or private flights into or over the territory of Japan provided that such flights follow the airway designated by the Minister of Land, Infrastructure, Transport and Tourism. Those that do not follow the airway designated by the Minister of Land, Infrastructure, Transport and Tourism must submit an application for permission 10 days prior of the intended flight.

## Non-scheduled Flights (Charters)

A foreign aircraft of any nationality must submit an application for permission to the Minister of Land, Infrastructure, Transport and Tourism at least ten days prior to the proposed date of flight in cases where his office or agent is designated within Japan or thirty days in other cases any commercial flight with a traffic stop in the territory of Japan, whether or not the flight will follow the airway designated by the Minister of Land, Infrastructure, Transport and Tourism. Applications should include:

- → Name, address and nationality
- > Nationality, type, registration mark of aircraft and call sign of aircraft to be used
- → Name of pilot-in-command, names and qualifications of crew members
- > Reasons for the necessity of the said transportation
- → Names and nationalities of passengers to be carried for remuneration
- → Description and quantity of cargos and its names to be carried for remuneration
- Classification and amount of fares, rates or charges of passengers or freight
- Route of flight (indicating intermediate stops), and flight sections and schedule intended for transportation of passenger or flight for remuneration
- → Name and address of the office or agent in cases where designated within Japan

### **Private Flights**

No need to obtain permission to carry out noncommercial or private flights into the territory of Japan provided that such flights follow the airway designated by the Minister of Land, Infrastructure, Transport and Tourism. Those that do not follow the airway designated by the Minister of Land, Infrastructure, Transport and Tourism must submit an application for permission 10 days prior of the intended flight.

### Float Planes

The IFIM Staff is not aware of any Float Plane requirements or restrictions.

### **Light Sport Aircraft**

The IFIM Staff is not aware of any Light Sport Aircraft requirements or restrictions.

#### Fees

There may be some landing charges (landing charges will vary by aircraft type, weight and airport), parking, and security, consumption, and air navigation fees.

#### Fuel

Jet A-1 is available at most AOE's. AvGas is not available.
