Flight Information

The accuracy and currency of information contained in this guide is uncertain due to the difficulty in obtaining the information and the rapidly changing environment. Aviators should always check with a country's aviation authority or a local aviation handler to determine any specific aircraft airworthiness/equipment and crew/passenger entry requirements.

Entry/Exit Requirements

Entry and exit requirements are for aircraft departing the United States non-stop to country of destination. These requirements do not include any technical stops. Please refer to Technical Stop section in Additional Flight Information for the country at which the technical stop will be made.

Entry and Exit documentation forms vary from country to country. In general, however, ICAO member countries will accept the following standard ICAO Annex 9 Entry/Exit documents:

- **+ General Declaration**
- → Passenger Manifest
- → Cargo Manifest
- Embarkation/Disembarkation Card
- Certificate of Residual Disinsection

Examples of these documents can be found at IFIM Home>General Information>International Flying Overview> ICAO Annex 9 Entry/Exit Documents. The acceptance of these ICAO documents must be confirmed by the appropriate AIS.

Entry Requirements (Departing the U.S.)

- → File an <u>eAPIS</u> manifest outbound (recommend inbound at this time, too)
- → File and activate international flight plan

→ Land at a designated airport of entry (AOE) – customs and immigration

The following entry documents are required:

Passengers -

- → Valid passport
- → Visa
- > Yellow Fever vaccination certificate

Pilots - Same as passengers

Note: Other pilot/crewmember requirements may be applicable in lieu of those stated. Contact appropriate AIS for further clarification prior to flight.

Aircraft -

- → General Declaration 1 for Customs, 1 for Immigration, 1 for Public Health
- → Passenger manifest 1 for Customs, 1 for Immigration, 1 for Public Health
- → Cargo manifest 1 for Customs
- → General declaration Health section indicating aircraft sprayed 30 minutes prior to arrival

Exit Requirements (Departing Comoros)

- → Same documentation as required for arrival (see Aircraft above)
- → Depart from an AOE
- → File eAPIS manifest if inbound to the U.S.
- → File an international flight plan
- → Call U.S. Customs at filed U.S. airport of entry

Additional Flight Information

Aircraft Instruments and Equipment

U.S. aircraft airworthiness and certification requirements may not meet other countries requirements. It is the responsibility of the pilot to determine if the aircraft meet those requirements.

The items listed below are for pilots' reference to determine if the aircraft meets minimum instrument and equipment requirements of the destination country. Additional equipment may be required to comply with the airspace navigation requirements.

VHF and HF communication and navigation equipment suitable for the route and landing

Note: If equipped with TCAS, ACAS or transponder, must comply with ICAO standards

Commercial air transport aircraft operating in the member states of ASECNA must be complied with the provisions of ICAO Annex 6 - Operation of aircraft, Part 1- International Commercial Air Transport- Aircraft, Chapter 6 (Aircraft instruments, Equipments and Flight documents) and Chapter 7 (Airplane Communication and Navigation Equipment).

All aircraft assigned to fly over an inhospitable region must be provided with special facilities including signaling, emergency and survival equipments and the manuals to operate such equipment. The requirements for flight over inhospitable regions are

extensive and too numerous to list. One should reference the free on-line AIP for details.

RVSM

<u>Domestic and International RVSM</u> guidance is provided on the IFIM Home Page. Click on the **Air Traffic** tab and select **Separation Standards** from the drop down list.

Technical Stop / Overflight

A request for a technical stop or overflight must be made to the National Agency of Civil Aviation and Meteorology (ANACM) at least 72 hours prior to the flight.

Non-scheduled Flights (Charters)

The requests for authorization to operate a series of non-scheduled commercial flights inbound for or outbound from the Union of the Comoros must be done in writing (mail, fax or AFTN message) no later than forty-five (45) days before the scheduled date of the first flight

Private Flights

The requests of authorization for noncommercial overflight and/or landing must be submitted to the National Agency of Civil Aviation and Meteorology of the Union of Comoros, in writing ten (10) days before the scheduled date of the flight, and by fax, email or AFTN message, no later than three (3) days before the scheduled date of the overflight and/ or landing.

Float Planes

The IFIM Staff is not aware of any Float Plane requirements or restrictions.

Light Sport Aircraft

The IFIM Staff is not aware of any Light Sport Aircraft requirements or restrictions

Fees

Users should anticipate varying fees for landing, enroute services, runway lighting facilties, apron lighting, passengers services, overtime, aircraft parking, cargo, fueling surcharge, security and air navigation. Check with the free online AIP for detailed information.

Fuel

Jet A1 is the only fuel available at the Moroni Prince Said Ibrahim airport.

VFR/Night VFR

The VFR flights are not allowed over and above the flight level 150.

VFR flights are not authorized at night, which means, during the period that begins 15 minutes after the sunset and finishes 15 minutes before the sunrise.

Island Hopping

The IFIM Staff is not aware of any Island Hopping requirements or restrictions.
