**TO AVOID CONFUSION DUE TO TWO IDENTIFIERS IN USE, AIJ WILL CONTINUE TO IDENTIFY AS "INTERJET" UNTIL 0500Z ON 27AUG2012. BEGINNING AT THAT TIME AIJ WILL IDENTIFY AS "ABC AEROLINEAS".**
