SUBJ: Aircraft Certification Directorates' Delegation Of Authority

- 1. Purpose of this Order. This order grants certain authority to the four aircraft certification directorates (defined in FAA Order 1100.2, Organization—FAA Headquarters) to manage technical policy and airworthiness projects for aircraft certification, including type, original airworthiness, and production certification programs.
- 2. Audience. The audience of this order is all Aircraft Certification Service directorate standards staff and their managers who have rulemaking responsibilities.

- **4.** What This Order Cancels. FAA Order 8000.51A, Aircraft Certification Directorates' Delegation of Authority, dated October 10, 2007.
- 5. Delegations of Authority.
- a. For the airworthiness standards and continued airworthiness requirements over which they have responsibility as stated in subparagraph 5e of this order, the aircraft certification directorates are delegated authority to:
 - (1) Issue, amend, suspend, or revoke type and supplemental type certificates.
 - (2) Grant or deny exemptions.
 - (3) Issue, amend, extend, or withdraw notices of proposed rulemaking.
- (4) Issue, amend, or cancel advisory circulars that establish acceptable means of compliance, per FAA Order 1320.46, Advisory Circular System, and subparagraph 5d of this order.
- (5) Issue national directives on applying type certification airworthiness standards and continued airworthiness requirements per FAA Order 1320.1, FAA Directives System and subparagraph 5c of this order.
- (6) Issue special conditions pursuant to Title 14 of the Code of Federal Regulations (14 CFR) §§ 11.19, 21.16, and 21.101(d).
- (7) Issue airworthiness directives on all associated aeronautical products (both foreign and domestic) as required by 14 CFR part 39, Airworthiness Directives.
 - (8) Make findings of equivalent safety per 14 CFR § 21.21(b)(1).

b. Each directorate is delegated authority to issue airworthiness directives on appliances (both foreign and domestic), as required by 14 CFR part 39, whose design approval holder is within their geographic boundaries.

- **c.** Each directorate is delegated authority to issue, amend, suspend, or revoke production approvals and original/recurrent airworthiness certificates within their geographic boundaries.
- **d.** Directorates will develop advisory circulars and regulations using a public notice and comment process. This ensures that all affected parties can join in developing advisory circulars and regulations to establish airworthiness standards for aircraft certification.
- **e.** Aircraft certification directorate airworthiness standards and continued airworthiness assignments are as follows:
 - (1) The Small Airplane Directorate is responsible for:
- (a) 14 CFR part 23, the airworthiness standards for normal, utility, acrobatic, and commuter category airplanes.
 - **(b)** 14 CFR part 31, the airworthiness standards for manned free balloons.
 - (c) Airworthiness criteria for gliders and airships.
 - (2) The Transport Airplane Directorate is responsible for:
 - (a) 14 CFR part 25, the airworthiness standards for Transport Category airplanes.
- **(b)** 14 CFR part 26 Continued Airworthiness and Safety Improvements for Transport Category Airplanes.
 - (3) The Rotorcraft Directorate is responsible for:
 - (a) 14 CFR part 27, the airworthiness standards for Normal Category Rotorcraft.
 - (b) 14 CFR part 29, the airworthiness standards for Transport Category Rotorcraft.
 - (c) Airworthiness criteria for powered lift aircraft.
 - (4) The Engine and Propeller Directorate is responsible for:
 - (a) 14 CFR part 33, airworthiness standards for airplane engines.
 - **(b)** 14 CFR part 35, the airworthiness standards for propellers.
- **f.** Each directorate will execute certification programs within their geographic boundaries. as described in Order 8100.5, Aircraft Certification Service Mission, Responsibilities, Relationships, and Programs.

6. Distribution. Distribute this order to the Washington headquarters director levels in the Aircraft Certification Service, Flight Standards Service, and Office of Environment and Energy; the branch levels of the regional aircraft certification directorates and flight standards divisions; all aircraft certification field offices, aircraft evaluation groups, and designated engineering representatives.
