SUBJ: CERTIFICATION OF MILITARY AIR NAVIGATION FACILITIES


1. PURPOSE. This Order delegates responsibility for negotiation with the military toward certification of all types of military facilities used or planned for use in the National Airspace System (NAS).
2. DISTRIBUTION. This Order is being distributed to Air Traffic, Flight Standards and Airway Facilities branches and to all air traffic field facilities in the Great Lakes Region. Information copies of the Order are being distributed to the Central and Eastern Region Aircraft Management Branches and the Columbus, Battle Creek and Minneapolis Flight Inspection District Offices (FIDO's).
3. DELEGATION. Air route traffic control center chiefs are delegated responsibility for obtaining written certification of those military NAVAIDS within their areas of jurisdiction required for use in the NAS.
4. ACTION.
  - a. When procedures originate within Flight Standards Service areas of responsibility which require use of a military NAVAID, the FIDO concerned shall request the appropriate air route traffic control center to initiate certification action in accordance with Order 6000.1A.
  - b. When procedures originate within Air Traffic Service areas of responsibility which require use of a military NAVAID, the request shall be routed to and handled by the appropriate center.
  - c. The center shall coordinate proposals with both the Regional Office (GL-530) and the appropriate FIDO prior to initiating certification action.
  - d. Upon completion of certification action, center chiefs shall accomplish notification per Handbook 7210.3, paragraph 309. The Air Traffic Division notification should be addressed to the attention of the Airspace and Procedures Branch, GL-530. Center chiefs are requested to complete the certification documents in quadruplicate, retaining the original for their files, and forward the three copies to GL-530, Electronics Branch, GL-470, and the Aircraft Management Branch (CE-220 or EA-220, as appropriate).

- e. GL-530 shall maintain a complete listing of all military NAVAIDS located within the Great Lakes Region area of responsibility which have been certified for use in the NAS. Coordination with adjacent regions, when required, shall be accomplished by GL-530.
  - f. Appendix 1 contains an updated list of military facilities which have been certified for use in the NAS.
5. CANCELLATION. Order CE 6000.3A dated 2/23/68 is cancelled for all Great Lakes facilities.
