## **Revise Helicopter Route 12**





RT. 12: INTERSTATE 95 FROM THE CAPITAL BELTWAY (I-495) TO LAUREL REPORTING POINT THEN TO FCC MONITORING STATION, THEN TO POWER PLANT THEN NORTHEAST TO THE BALTIMORE BELTWAY (I-695). THEN EAST TO LOUDON PARK CEMETERY THEN TO BABE RUTH BALL FIELD THEN THROUGH BALTIMORE CITY VIA THE FORT MC HENRY TUNNEL, THEN NORTHEAST.

ALTITUDES: SHOULD BE AT OR BELOW 1000 FEET MSL FROM (1-495) TO LAUREL REPORTING POINT. THEN SHOULD BE AT OR BELOW 500 FEET MSL FROM LAUREL REPORTING POINT TO FCC MONITORING STATION TO POWER PLANT THEN NORTHEAST TO (1-695). THEN EAST SHOULD BE AT OR BELOW 1000 FEET MSL FROM (1-695) TO LOUDON PARK CEMETARY TO BABE RUTH BALL FIELD THEN TO THE FORT MC HENRY TUNNEL REPORTING POINT.
