Flight Attendant Certificate of Demonstrated Proficiency

Background: In the fall of 2003, Congress established a flight attendant certification requirement under the Vision 100-Century of Aviation Reauthorization Act (the Act). The Act requires that after December 11, 2004, no person may serve as a flight attendant aboard an aircraft of an air carrier unless that person holds a Certificate Of Demonstrated Proficiency (certificate) issued by the FAA.

The Act defines a flight attendant as an individual who works in the cabin of an aircraft that has 20 or more seats and is used by a part 121 or part 135 air carrier to provide air transportation. *The FAA will not issue a Certificate of Demonstrated Proficiency to any flight attendant that does not meet this definition.*

Flight attendants are not required to carry the certificate. If requested, flight attendants shall present their certificate to the FAA, the National Transportation Safety Board, or another Federal agency within a reasonable period of time after the date of request. The FAA policy for "a reasonable period of time" is 15 days.

Key Provisions of the Vision 100-Century of Aviation Reauthorization Act

Among other provisions, the Act provides the following:

- A. *Definition of the term flight attendant*. A flight attendant works in the cabin of an aircraft that has 20 or more seats and is operated by an air carrier to provide air transportation.
- B. *Scope*. The Act applies to flight attendants of air carriers providing air transportation using airplanes with 20 or more passenger seats under Title of the Code of Federal Regulations (14 CFR) parts 121 and 135.
- C. *Distinction*. The Act distinguishes between this certificate and an airman's certificate. This certificate is not an airman's certificate as specified in Title 49 of the United States Code (49 U.S.C.), section 44703; it is a separate kind of certificate as specified in 49 U.S.C., section 44728.
- D. *Appearance of the certificate*. The Certificate of Demonstrated Proficiency is similar in size and appearance to certificates issued to airmen. Each certificate is numbered, contains the name, address and description of the individual to whom the certificate is issued and contains the airplane group for which the certificate is issued (Group 1 = Propeller-driven; Group 2 = Turbojet-powered, as defined in <u>14 CFR 121.400</u>).

Applying for the Certificate of Demonstrated Proficiency

The Director of Operations (DO) must apply for a flight attendant's Certificate of Demonstrated Proficiency in the following circumstances:

- A flight attendant without an existing certificate completes initial training.
- A flight attendant changes air carrier (update air carrier in FAA database)

The DO is responsible for applying for a flight attendant's Certificate of Demonstrated Proficiency once the flight attendant has successfully completed all requirements of the FAA-approved training program, including operating experience. The DO applies for the certificate by entering a record into the webbased FAA Flight Attendant Certification System. The Certificate of Demonstrated Proficiency is effective immediately upon receipt by the FAA of this record. The FAA will mail a hardcopy of the certificate to the flight attendant within 10 to 14 days. The certificate is the property of the individual flight attendant, not the air carrier who applied for it.

When a flight attendant completes training with a second (or subsequent) airline, the DO will update the information in the in the <u>FAA Airline database</u> The Air Carrier information in the FAA database is updated. The only exception is when an air carrier trains a flight attendant on an additional aircraft Group. A new certificate will be processed and mailed.

To apply for the Certificate of Demonstrated Proficiency:

(1) <u>DO must request access to the Flight Attendant Certification System</u>, in writing and on company letterhead. Include the air carrier designator issued by the FAA and the *DO's e-mail address* in the request. Email the request to:

The FAA will email a confirmation message to the DO containing a link to the Flight Attendant Certification System, a user ID and password. If the DO has any questions or encounters system difficulties, they may contact Airmen Certification at <u>9-AMC-AFS760-airmen@faa.gov</u> or 1-866-878-2498.

(2) Once the DO determines that a person has successfully completed the FAAapproved flight attendant training program, including the operating experience required by Title 14 of the Code of Federal Regulations (<u>14 CFR 121.434</u>), they must enter the record in the system. Enter the following data for each record:

- Name, (enter first/middle name when establishing the record with FAA)
- Date of birth,
- Place of birth,
- Mailing address,
- Physical description (height, weight, hair and eye color, and gender),
- Citizenship, and
- Qualification in Group 1, Group 2, or both.
- (3) If a flight attendant previously received a Certificate of Demonstrated Proficiency as a result of training at another air carrier, verify a Certificate of Demonstrated Proficiency has been issued by one of the following methods:
 - The flight attendant presents the hardcopy certificate to the DO, or to the DO's representative, or
 - The DO, or DO's representative, queries the <u>FAA Airmen Certification</u> <u>database</u> and finds an existing certificate.

Applicability of the Privacy Act: Under the Privacy Act, personal information is not available to the public. A flight attendant's address, physical description, date of birth and place of birth is not available to the public. Only basic certification information of an identified individual may be released to the public, such as certificate number, ratings (Group 1, Group 2), and date of issue.

Updating an Existing Flight Attendant Certificate

Adding an Additional Rating (Group):

The following procedures apply in the following circumstances:

- An air carrier operates both Group 1 and Group 2 airplanes, but only trains a flight attendant on one group during initial training, or
- A flight attendant holding a certificate with one rating completes training at a subsequent air carrier that operates a different or additional airplane group.

If the air carrier later trains the flight attendant on the second group, the DO must update the record in the System reflecting the new group qualification.

Each flight attendant should only have one certificate, and that one certificate should reflect all the ratings held by the flight attendant. The air carrier is not printed on the certificate.

To add an additional group to an existing certificate:

- (1) Log into the Flight Attendant Certification System.
- (2) Select "Update Existing Flight Attendant Certificate".
- (3) Enter the certificate number of the flight attendant. The screen will display pre-filled information for that flight attendant.
- (4) Change the physical description, address, and ratings, as required. If the flight attendant already holds one rating (i.e. Group 1) and is adding another rating (i.e. Group 2), select the rating "Group 1&2" from the drop-down box.
- (5) The FAA will then issue a certificate with both ratings.

Changing Personal Information in the System

If the personal information shown on the flight attendant's certificate; such as name, date of birth, citizenship, or gender, is in error or should change; a flight attendant may request the information be changed in the FAA database.

Include the following information in an email to <u>9-AMC-AFS-760-airmen@faa.gov</u> :

- Name
- Certificate number
- Reason for the request

Include a copy of formal documentation showing evidence of the change(s) such as a marriage certificate, a divorce decree, or a court order.

Changing an Address in the System:

A flight attendant is not required to notify the FAA of an address change, but may do so voluntarily. Follow the procedures for changing personal information.

To request a replacement certificate on-line:

(1) Create an account with Airmen Online Services. Follow the directions found at <u>Airmen Online Services</u>

NOTE: In order to create an account with Airmen Online Services, the flight attendant must know the number of his/her original Certificate of Demonstrated Proficiency. They can contact Airmen Certification Branch to obtain this for registration. The name and certificate number must match FAA database, to create an account.

Flight Attendant Certificate of Demonstrated Proficiency Frequently Asked Questions (FAQ)

I am the Director of Operations for a non-part 121/135 operator with an airplane with more than 20 seats. Can I apply for Certificates of Demonstrated Proficiency for the flight attendants we employ?

No. The FAA will not issue a Certificate of Demonstrated Proficiency to a flight attendant that does not meet the definition of "flight attendant" in the Vision 100-Century of Aviation Reauthorization Act.

I am the Director of Operations for a part 135 operator with an airplane with less than 20 seats. We employ flight attendants and have an FAA-approved flight attendant training program. Can I apply for Certificates of Demonstrated Proficiency for the flight attendants we employ? No. The FAA will not issue a Certificate of Demonstrated Proficiency to a flight attendant that does not meet the definition of "flight attendant" in the Vision 100-

Century of Aviation Reauthorization Act.

Is the Certificate of Demonstrated Proficiency an air carrier accountable item, like a flight attendant manual or a company ID?

No. The Certificate of Demonstrated Proficiency is the property of the flight attendant. The air carrier should not collect the flight attendant's certificate at the conclusion of the flight attendant's employment with the carrier. The air carrier is not printed on the certificate.

Does an FAA Aviation Safety Inspector (ASI) need to check for a flight attendant's Certificate of Demonstrated Proficiency during routine surveillance?

A flight attendant is not required to carry his or her Certificate of Demonstrated Proficiency. If requested a flight attendant shall present his or her certificate to the FAA, the NTSB or other Federal agency within a reasonable time after the date of request. The FAA has defined "reasonable" as 15 days. An ASI may verify a flight attendant has been issued a Certificate of Demonstrated Proficiency by using the SPAS airmen search (MSAT-A) or https://amsrvs.registry.faa.gov/airmeninquiry/
