Dear CAPT Markovich:

Based on United States Navy (USN) Commander approval, the Naval COMVAQWINGPAC INSTRUCTION 3710.4A and COMNAVAIRPAC/COMNAVAIRLANT INSTRUCTION 3700.2D are acceptable to the Federal Aviation Administration (FAA). FAA acceptance of the Navy maneuvers package should not be construed as a special waiver, exemption or exception to the guidelines and provisions of an air show Certificate of Waiver, FAA Form 7711-1 Certificate of Waiver, (COW).

FAA acceptance is confirmation that the maneuvers, as presented in the 2025 maneuvers and instructions listed above, meet FAA guidelines and special provisions.

This letter authorizes the performance of the USN EA-18 demonstrations and Legacy Flight (LF) demonstrations.

The following are the accepted civilian Legacy Flight program pilots permitted to fly in dissimilar formation with the above listed pilots as long as they meet all FAA requirements for flying their respective aircraft and hold a current industry formation flying credential (FAST) and (if performing aerobatics) Statement of Aerobatic Competency, FAA Form 8710-7 (SAC):

Non-aerobatic flyovers over an open-air assembly of people (e.g., stadiums, parades, funeral) subject to §91.119 (b) are authorized for USN EA-18 Demonstration Team and USNLF at or above 500 feet above the highest obstacle and 1,000 feet either side of the intended flightpath when a flyover CoW is issued.

We will make the 2025 USN EA-18 maneuver packages available to the FAA Aviation Events Specialist (AES) and FSDOs. This package will also be used when conducting site feasibility determinations and airspace requirements for future demonstrations and completion of DD Form 2535.

All accidents and incidents must be reported to the Manager, General Aviation Operations Section (AFS-830) and provide a briefing paper within 24 hours.
