

## FAA Approved Aviation Training Devices (ATD) as of 12/31/2024

The Air Transportation Division (AFS-200) provides for the evaluation, qualification and approval of ATD's as a **Basic or Advanced Aviation Training Device (BATD/AATD)**, as permitted under **14 CFR part 61.4(c)**. Advisory circular **AC 61-136, FAA Approval of Aviation Training Devices and Their Use for Training and Experience** as amended provides Federal Aviation Administration (FAA) guidance for ATD qualification, approval and use. An FAA Letter of Authorization (LOA) is provided to the manufacturer for each model that qualifies. The manufacturer is responsible for providing a copy of the LOA, *and* the FAA approved qualification and approval guide (QAG) to each operator of an ATD. The QAG identifies the approved aircraft configurations and design criteria. Guidance for aviation safety inspector oversight is provided in

**FAA Order 8900.1 Volume 11, Chapter 10, Section 1, Aviation Training Device.**

*Note: ATD's are not Flight Training Devices (FTD) or Full Flight Simulators (FSS) qualified under 14 CFR part 60.*

**ATD's must be accompanied by the signed FAA Letter of Authorization (LOA) and Qualification and Approval Guide (QAG)** documents when used to satisfy any pilot time experience requirements specified in 14 CFR part 61 or 141.

- **The LOA** lists the specific part 61 & 141 time or training credit allowances, are **valid for 60 calendar months**, and must contain an expiration date to be valid. See important conditions and limitations listed in each LOA.
- **A copy of the LOA must be provided to any individual using pilot time logged in an ATD to meet training or experience requirements** identified in 14 CFR Part 61 or 141 pursuant to an airman certificate, rating, or privilege.
- Designated pilot examiners should request to see a copy of the LOA, when ATD pilot time is used to meet the minimum pilot time experience requirements for an airman certificate or rating.
- Aircraft "type" rating experience requirements cannot be accomplished in an ATD. Procedural ground training only.
- Pilot time in an ATD can only be logged as Total Time, Instrument Time, and/or Instruction Received (See FAA Form 8710-1).
- **Pilot certification practical tests, Part 141 stage exams/end of course evaluations and the flight portion of a Flight Review cannot be accomplished in an ATD.**
- BATD or AATD's cannot be used to satisfy training requirements specified in part 121 or part 135 training and qualification programs (See FAA Order 8900.1 Volume 3, Chapter 19, Section 6 Page 13).

*Note: Businesses listed with asterisk (\*) do not manufacturer ATD's, but hold a LOA for the trainer listed.*
