

DBE Uniform Form

- Line 16: The “Non-Minority” category is reserved for any firms whose owners are not members of the presumptively disadvantaged groups already listed, but who are either “women” OR eligible for the DBE program on an individual basis. All DBE firms must be certified by the Unified Certification Program to be counted in this report.


- The inclusion of prime contracts in Column C likely will be the exception and not the rule since most DBE participation is obtained through subcontracts. However, when DBE prime contracts are included in column C, you should in a footnote include the number of DBE prime contracts reported.

Reporting DBE Participation

- The number of contracts reported in column 18C may be larger, smaller, or the same as the number in column 18A.
- To illustrate the point, assume that only one prime contract is underway during the reporting period. If the prime contractor is a non-DBE with 3 DBE subcontractors, the number reported in column 18C will be higher than column 18A. By contrast, if a non-DBE prime contract reported in column 18A has no DBE subcontractors, the number reported in column 18C will be less than column 18A.
- If the prime contract involves a DBE prime contractor with no DBE subcontractors, the number in column 18A and column 18C would be the same.

DBE Uniform Form-General Information

- You might be reporting in Sections A, B, C and D if you have awards/commitments (A and B), payments on ongoing contracts (C) and completed contracts (D).
- You might be reporting in only Section C if you have only payments on ongoing contracts.
- You might be reporting in Section C and D if you have payments on ongoing contracts and completed contracts.
- You might be reporting in only Section D if you have only completed contracts.

AIP Numbers-Line 2

- The AIP numbers you enter in line 2 apply to all the data that you enter on the form.
 - If you enter prior year AIP numbers (prior to the year that you are reporting), you may also have data to enter in Section D, completed contracts.

Reporting DBE Participation

- FAA Recipient awarded \$1,200,000 of federal assisted prime contracts. \$100,000 of the federally assisted prime contracts was awarded to 93 DBEs.
- Of the \$1,200,000, there were \$325,000 in subcontracts awarded to 50 subcontractors; \$25,000 of that amount was awarded to 42 DBEs. Two (2) of those subcontracts awarded to DBEs in the amount of \$8,000 did not have a DBE contract goal.
- Of the 135 DBE participants, 50 are Black American women (\$10,000), 50 are Hispanic American women (\$7,000) and 35 are Asian-Pacific American women (\$8,000).
- FAA Recipient currently has 100 ongoing contracts currently in progress, 5 of which have DBE participation. It has made \$25,000 of payments currently, and \$5,000 of those payments went to 2 DBEs.
- FAA Recipient has completed/paid/closed one race-conscious FAA assisted contract in the amount of 980,000. The DBE participation needed to meet the goal was \$120,000. The total DBE participation is \$90,000.





- FAA Recipient has 4 sub-concessions (firms that have an agreement with a prime concession); 2 are ACDBES obtained from an RFQ with an ACDBE goal. Total sub-concession revenue is \$630,500 and of that amount, the two ACDBE subs revenue is \$140,000.
- FAA Recipient has 1 ACDBE parking management contract obtained from an RFQ with an ACDBE goal. (Only ACDBE participation is entered for management contracts). Total ACDBE revenue for this contract is \$200,000.
- FAA Recipient purchased \$225,000 for goods and services from 6 firms. Two (2) of the firms are ACDBEs obtained from an RFQ with an ACDBE goal. The ACDBEs goods and services purchases totaled \$85,000.
- During the reporting period, the FAA recipient contracted with 2 new prime concessions with total revenue of \$550,000. One (1) of the new prime concessions is an ACDBE with revenue of \$130,000 obtained through typical prime concession competitive bidding procedures. (This data is included in Section 5.)


