

1. Notice of Intent
2. Notice of Availability
3. Feedback from ACR on EIS
4. Review of ACR Comments
5. Notice of Availability final
6. Notification sent to ACR

# Step by step process

between ARP and ARC (continued)

7. ACR Review
8. ACR request for information
9. Failure to provide information to ACR
10. Notification to higher officials
11. Documentation from ACR to POC
