1. Authority: This Order is issued to Midland International Airport (referred to as MAF) under 51 U.S.C. Subtitle V, chapter 509, and 14 C.F.R. Ch. III.
2. Purpose: This Order modifies License No. LSO 14-015, issued on September 15, 2014, by the Federal Aviation Administration's Office of Commercial Space Transportation (FAA/AST) authorizing MAF to operate certain portions of MAF as a launch site at Midland, Texas, and prescribes as conditions to License No. LSO 14-015, certain additional requirements applicable to the authorization.
3. Authorization: MAF is authorized to operate a launch site at MAF, an airport that is certificated for commercial service under 14 C.F.R. Part 139 and federally obligated under 49 USC section 47107, et.seq. and section 13(g) of the Surplus Property Act of 1944, as amended, 49 U.S.C. section 47152:
  - (a) for U.S. Government or FAA-licensed or permitted launches; and
  - (b) as required by 14 C.F.R. § 420.51, in accordance with the representations in MAF's license application, and any subsequent amendments approved by AST as of the date of this Order, and any modifications to the license issued by the FAA under 14 C.F.R. § 420.47.

4. License Term: The term of License No. LSO 14-015 authorizing MAF to operate a launch site at Midland, Texas is five (5) years from September 15, 2019, the effective date of its renewal.
