

15S.21 Runway Incursions (Category A and B)

Description

Reduce Category A & B (most serious) runway incursions to a rate of no more than .395 per million operations, and maintain or improve through FY2018.

Special Designations: OSI, Agency Priority Goals, DOT Goals, STI

Commentary (March 2015)

The target for Runway Incursion (RI) Rate (Category A and B) is 0.395 per million operations. The March status is Yellow. Through March FY 2015, the preliminary cumulative rate for category A&B runway incursions is 0.385 per million operations. The revised cumulative rate for February is 0.470. There were 0 A/B RI in the month of March 15. There have been 9 Category A/B RI in FY 2015:

- Oct - 1 Category A Pilot Deviation (PD)
- Oct - 1 Category B Operational Incident (OI)
- Nov - 1 Category A Pilot Deviation (PD)
- Dec - 2 Category A Operational Incident (OI)
- Jan - 2 Category A Pilot Deviations (PD)
- Jan - 1 Category A Vehicle Pedestrian Deviation (VPD)
- Feb - 1 Category A Pilot Deviations (PD)

Commentary (February 2015)

The target for Runway Incursion (RI) Rate (Category A and B) is 0.395 per million operations. The February status is Red. Through February FY 2015, the current preliminary cumulative rate for category A&B runway incursions is 0.471 per million operations. The revised cumulative rate for January is 0.511.

There were 1 A/B RI in the month of February 2015. Of the 9 A&B RIs so far:

- 5 are Pilot Deviations (4 are GA, 1 is Commercial)
- 3 are Operation Incidents (ATC)
- 1 is a Vehicle Deviation


