TITLE 14 CFR PART 97.37**

Bearings, headings, courses, tracks and radials are magnetic. Elevations and altitudes are in feet, MSL. Altitudes are minimum altitudes unless otherwise indicated.  
Ceilings are in feet above airport elevation. Distances are in nautical miles. Visibilities are in statute miles or feet RVR unless otherwise indicated.

**TAKEOFF MINIMUMS:**

RWY 11: STANDARD WITH MINIMUM CLIMB OF 272 FT PER NM TO 2200 OR 4500-3 FOR VCOA.

RWY 29: STANDARD WITH MINIMUM CLIMB OF 326 FT PER NM TO 5700 OR 4500-3 FOR VCOA.

**TEXTUAL DEPARTURE PROCEDURES:**

RWY 11: CLIMB ON A HEADING BETWEEN 100 CW TO 130 FROM DEPARTURE END OF RUNWAY.

RWY 29: CLIMB ON A HEADING BETWEEN 300 CW TO 330 FROM DEPARTURE END OF RUNWAY.

**VISUAL CLIMB OVER AIRPORT:**

RWY 11: OBTAIN ATC APPROVAL FOR VCOA WHEN REQUESTING IFR CLEARANCE. CLIMB IN VISUAL CONDITIONS TO CROSS MESA DEL RAY AIRPORT AT OR ABOVE 4700 BEFORE PROCEEDING ON COURSE.

RWY 29: OBTAIN ATC APPROVAL FOR VCOA WHEN REQUESTING IFR CLEARANCE. CLIMB IN VISUAL CONDITIONS TO CROSS MESA DEL RAY AIRPORT AT OR ABOVE 4700 BEFORE PROCEEDING ON COURSE.

NOTE: RWY 11: VEHICLE ON ROAD 3 FT FROM DER, 115 FT LEFT OF CENTERLINE, 375 FT MSL. TREES, BUILDING BEGINNING 5 FT FROM DER, 234 FT RIGHT OF CENTERLINE, UP TO 16 FT AGL/385 FT MSL. BUILDING, TERRAIN, FENCE BEGINNING 16 FT FROM DER, 369 FT LEFT OF CENTERLINE, UP TO 10 FT AGL/386 FT MSL. TANK 167 FT FROM DER, 518 FT LEFT OF CENTERLINE, 15 FT AGL/393 FT MSL. TREES BEGINNING 479 FT FROM DER, 370 FT LEFT OF CENTERLINE, UP TO 48 FT AGL/421 FT MSL.
