TAKEOFF ALL RWYS: CLIMB ON ASSIGNED HEADING FOR RADAR VECTORS TO CROSS TEREET AT OR ABOVE 3000 THEN ON TRACK 334.80 TO BRSTL, THEN ON (TRANSITION). MAINTAIN 3000.
EXPECT FILED ALTITUDE 10 MINUTES AFTER DEPARTURE.

ALL AIRCRAFT: ATC CLIMB GRADIENT: IF UNABLE TO ACCEPT CLIMB RATE, ADVISE ATC PRIOR TO TAXI. RWY 14: 400 FT/NM TO 430.
