Bearings, headings, courses, tracks and radials are magnetic. Elevation and altitudes are in feet MSL. Altitudes are minimum altitudes unless otherwise indicated.  
Ceilings are in feet above airport elevation. Distances are in nautical miles. Visibilities are in statute miles or feet RVR unless otherwise indicated.

**TAKEOFF MINIMUMS:**

RWY 35: STANDARD

RWY 8: STANDARD WITH A MINIMUM CLIMB OF 391 FT PER NM TO 2600 OR 1700-2 ½ FOR CLIMB IN VISUAL CONDITIONS.

RWY 17: 200-1 ½ OR STANDARD WITH A MINIMUM CLIMB OF 268 FT PER NM TO 500.

RWY 26: 300-1 ¾ OR STANDARD WITH A MINIMUM CLIMB OF 324 FT PER NM TO 600.

**TEXTUAL DEPARTURE PROCEDURES:**

RWY 8: FOR CLIMB IN VISUAL CONDITIONS: CROSS AUGUSTA RGNL AT BUSH FIELD AIRPORT AT OR ABOVE 1700 BEFORE PROCEEDING ON COURSE. WHEN EXECUTING VCOA, NOTIFY ATC PRIOR TO DEPARTURE.

RWY 17: CLIMB HEADING 172.21 TO 900 BEFORE TURNING LEFT.

RWY 26: CLIMB HEADING 262.22 TO 1000 BEFORE PROCEEDING ON COURSE.

RWY 35: CLIMB HEADING 352.22 TO 1200 BEFORE TURNING RIGHT.

NOTE: RWY 17, BUSH 746 FT FROM DER, 616 FT LEFT OF CENTERLINE, UP TO 14 FT AGL/ 158 FT MSL. TREES BEGINNING 1700 FT FROM DER, LEFT AND RIGHT OF CENTERLINE, UP TO 100 FT AGL/339 FT MSL.

NOTE: RWY 26, TREES BEGINNING 992 FT FROM DER, 294 FT LEFT OF CENTER LINE, UP TO 100 FT AGL/355 FT MSL. TREES BEGINNING 1254 FT FROM DER, 175 FT RIGHT OF CENTERLINE, UP TO 100 FT AGL/419 FT MSL. BUILDING 1344 FT FROM DER, 436 LEFT OF CENTERLINE, UP TO 31 FT AGL/175 FT MSL. LT POLE 1015 FT FROM DER, 287 FT RIGHT OF CENTERLINE, UP TO 31 FT AGL/175 FT MSL
