Bearings, headings, courses, tracks and radials are magnetic. Elevation and altitudes are in feet MSL. Altitudes are minimum altitudes unless otherwise indicated.
Ceilings are in feet above airport elevation. Distances are in nautical miles. Visibilities are in statute miles or feet RVR unless otherwise indicated.

TAKEOFF MINIMUMS:

RWY 3, 300 – 1 ¼ .

RWY 21, STANDARD WITH MINIMUM CLIMB OF 275 FT PER NM TO 1900 OR 1400 – 3 FOR CLIMB IN VISUAL CONDITIONS.

TEXTUAL DEPARTURE PROCEDURES:

RWY 3, CLIMB HEADING 038.76 TO 1700 BEFORE PROCEEDING ON COURSE.

RWY 21, CLIMB HEADING 218.76 TO 2000 BEFORE PROCEEDING ON COURSE OR FOR CLIMB IN VISUAL CONDITIONS, CROSS WAYNE COUNTY AIRPORT AT OR ABOVE 2200 BEFORE PROCEEDING ON COURSE. WHEN EXECUTING VCOA, NOTIFY ATC PRIOR TO DEPARTURE.
