RWY 17, 300-2 ¼ OR STANDARD WITH MINIMUM CLIMB OF 260 FT PER NM TO 700.
RWY 30, STANDARD WITH MINIMUM CLIMB OF 235 FT PER NM TO 1200 OR 1300-2 ½ FOR CLIMB IN VISUAL CONDITIONS.

RWY 12, CLIMB HEADING 121.04 TO 800 THEN CLIMBING RIGHT TURN TO CON VORTAC BEFORE PROCEEDING ON COURSE, OR FOR CLIMB IN VISUAL CONDITIONS CROSS CONCORD MUNI AIRPORT AT OR ABOVE 1500 BEFORE PROCEEDING ON COURSE. WHEN EXECUTING VCOA, NOTIFY ATC PRIOR TO DEPARTURE.
RWY 17, CLIMB HEADING 171.06 TO 1000 BEFORE TURNING LEFT.
RWY 30, CLIMB HEADING 301.04 TO 900 BEFORE PROCEEDING ON COURSE, OR FOR CLIMB IN VISUAL CONDITIONS CROSS CONCORD MUNI AIRPORT AT OR ABOVE 1500 BEFORE PROCEEDING ON COURSE. WHEN EXECUTING VCOA, NOTIFY ATC PRIOR TO DEPARTURE.
RWY 35, CLIMB HEADING 341 TO 1200 BEFORE PROCEEDING ON COURSE.
