TAKEOFF MINIMUMS AND OBSTACLE DEPARTURE PROCEDURES (ODP)

Bearings, headings, courses, tracks and radials are magnetic. Elevation and altitudes are in feet MSL. Altitudes are minimum altitudes unless otherwise indicated.
Ceilings are in feet above airport elevation. Distances are in nautical miles. Visibilities are in statute miles or feet RVR unless otherwise indicated.

TAKEOFF MINIMUMS:

RWY 18, 23, 36: STANDARD.

RWY 5, STANDARD WITH MINIMUM CLIMB OF 255 FT PER NM TO 1000, OR 1000-2 ½ FOR CLIMB IN VISUAL CONDITIONS.

TEXTUAL DEPARTURE PROCEDURES:

RWY 5: FOR CLIMB IN VISUAL CONDITIONS, CROSS GREENWOOD-LEFLORE AIRPORT AT OR ABOVE 1000 BEFORE PROCEEDING ON COURSE. WHEN EXECUTING VCOA, NOTIFY ATC PRIOR TO DEPARTURE.

TAKEOFF OBSTACLE NOTES:

NOTE: RWY 5, TREES BEGINNING 95 FT FROM DER, 6 FT LEFT OF CENTERLINE, UP TO 49 FT AGL/240 FT MSL. TREES BEGINNING 765 FT FROM DER, 42 FT RIGHT OF CENTERLINE, UP TO 84 FT AGL/180 FT MSL. TREES BEGINNING 2812 FT FROM DER, LEFT AND RIGHT OF CENTERLINE, UP TO 99 FT AGL/259 FT MSL. TREES BEGINNING 1.2 NM FROM DER, 1608 FT RIGHT OF CENTERLINE, UP TO 123 FT AGL/392 FT MSL.

NOTE: RWY 23, BUSHES BEGINNING 137 FT FROM DER, 219 FT LEFT OF CENTERLINE, UP TO 24 FT AGL/ 160 FT MSL. BUSHES AND TREES BEGINNING 233 FT FROM DER, 20 FT RIGHT OF CENTERLINE, UP TO 82 FT AGL/251 FT MSL. TREES BEGINNING 1031 FT FROM DER, 14 FT LEFT OF CENTERLINE, UP TO 112 FT AGL/252 FT MSL.

NOTE: RWY 36, SIGN 25 FT FROM DER, 242 FT RIGHT OF CENTERLINE, 3 FT AGL/148 FT MSL. TREES BEGINNING 743 FT FROM DER, 91 FT LEFT OF CENTERLINE, UP TO 95 FT AGL/257 FT MSL. TREES BEGINNING 1037 FT FROM DER, 662 FT RIGHT OF CENTERLINE, UP TO 45 FT AGL/242 FT MSL.
