Bearings, headings, courses, tracks and radials are magnetic. Elevation and altitudes are in feet MSL. Altitudes are minimum altitudes unless otherwise indicated.
Ceilings are in feet above airport elevation. Distances are in nautical miles. Visibilities are in statute miles or feet RVR unless otherwise indicated.

TAKEOFF MINIMUMS:

RWY 16: 500-3 OR STANDARD WITH MINIMUM CLIMB OF 324 FT PER NM TO 2000.
RWY 34: 600-3 WITH MINIMUM CLIMB OF 229 FT PER NM TO 1400 OR 1800-3 FOR CLIMB IN VISUAL CONDITIONS.

TEXTUAL DEPARTURE PROCEDURES:

RWY 16: CLIMB HEADING 165.99 TO 1400 BEFORE PROCEEDING ON COURSE.
RWY 34: CLIMB HEADING 000.99 TO 2800 BEFORE TURNING WEST OR FOR CLIMB IN VISUAL CONDITIONS: CROSS MEADOW BROOK FIELD AIRPORT AT OR ABOVE 2300 BEFORE PROCEEDING ON COURSE. WHEN EXECUTING VCOA, NOTIFY ATC PRIOR TO DEPARTURE.
