**NOTE: RWY 10,** TREES BEGINNING 2490 FT FROM DER, 32 FT RIGHT OF CENTERLINE, UP TO 94 FT AGL/284 FT MSL. TREES BEGINNING 84 FT FROM DER, 58 FT LEFT OF CENTERLINE, UP TO 83 FT AGL/273 FT MSL.

**NOTE: RWY 23,** TREES BEGINNING 575 FT FROM DER, 363 FT RIGHT OF CENTERLINE, UP TO 100 FT AGL/285 FT MSL. TREES BEGINNING 1139 FT FROM DER, 88 FT LEFT OF CENTERLINE, UP TO 100 FT AGL/285 FT MSL.

**NOTE: RWY 28,** TREES, POLE AND TOWER BEGINNING 1001 FT FROM DER, 23 FT RIGHT OF CENTERLINE, UP TO 158 FT AGL/350 FT MSL. TREES BEGINNING 981 FT FROM DER, 4 FT LEFT OF CENTERLINE, UP TO 94 FT AGL/292 FT MSL.


