RWY 22: CLIMBING LEFT TURN HEADING 120 AND ELP R-150 TO 9000. THEN PROCEED ON COURSE.  
RWY 26L: CLIMBING LEFT TURN HEADING 120 AND ELP R-150 TO 9000, THEN PROCEED ON COURSE.
