

TAKEOFF MINIMUMS AND OBSTACLE DEPARTURE PROCEDURES (ODP)

Bearings, headings, courses, tracks, and radials are magnetic. Elevations and altitudes are in feet, MSL. Altitudes are minimum altitudes unless otherwise indicated. Ceilings are in feet above airport elevation. Distances are in nautical miles. Visibilities are in statute miles or feet RVR unless otherwise indicated.

(1) TAKEOFF MINIMUMS:

RWY 09, 18, 36 STANDARD.

RWY 27, STANDARD WITH MINIMUM CLIMB OF 250' PER NM TO 1,600 OR 1000 – 2 1/2 FOR CLIMB IN VISUAL CONDITIONS.

(2) TEXTUAL DEPARTURE PROCEDURE:

RWY 27 – FOR CLIMB IN VISUAL CONDITIONS: CROSS CARL R KELLER FIELD AT OR ABOVE 1,400 MSL BEFORE PROCEEDING ON COURSE.

VEHICLES ON ROAD 475' FROM DER, 31' RIGHT OF CENTERLINE 15' AGL/604' MSL. NOTE: RWY 27, MULTIPLE TREES BEGINNING 1,210' FROM DER, 176' LEFT OF CENTERLINE, UP TO 65' AGL/650' MSL. POLE 1,066' FROM DER, 609' RIGHT OF CENTERLINE, 35' AGL/620' MSL. MULTIPLE TREES BEGINNING 2,558' FROM DER, 311' RIGHT OF CENTERLINE, UP TO 91' AGL/676' MSL. (CONT.)
