RWY 18, CLIMB TO 2100, THEN CLIMBING LEFT TURN VIA 331 BEARING TO ILI NDB. CLIMB IN ILI NDB/DME HOLDING PATTERN (S, RT, 006.00 INBOUND) TO 4500 BEFORE PROCEEDING ENROUTE.

RWY 26, CLIMB HEADING 243.41 TO 2100, THEN CLIMBING LEFT TURN VIA 044 BEARING TO ILI NDB. CLIMB IN ILI NDB/DME HOLDING PATTERN (S, RT, 006.00 INBOUND) TO 4500 BEFORE PROCEEDING ENROUTE.

RWY 36, CLIMB TO 2900, THEN CLIMBING LEFT TURN VIA 141 BEARING TO ILI NDB. CLIMB IN ILI NDB/DME HOLDING PATTERN (S, RT, 006.00 INBOUND) TO 4500 BEFORE PROCEEDING ENROUTE.
