RWY 28, 400-2 ¾ OR STANDARD WITH MINIMUM CLIMB OF 210 FT PER NM TO 1500 OR ALTERNATIVELY, WITH STANDARD TAKEOFF MINIMUMS AND A NORMAL 200 FT PER NM CLIMB GRADIENT, TAKEOFF MUST OCCUR NOT LATER THAN 1200 FT PRIOR TO DER. ATC CLIMB OF 230 FT PER NM TO 5000.

FOR CLIMB IN VISUAL CONDITIONS: CROSS GATLINBURG-PIGEON FORGE AIRPORT WESTBOUND ON VXV VORTAC R-102 AT OR ABOVE 1900 MSL TO VXV VORTAC; CONTINUE CLIMB TO 5000 BEFORE PROCEEDING ON COURSE. WHEN EXECUTING VCOA, NOTIFY ATC PRIOR TO DEPARTURE.

RWY 28 - CLIMB ON HEADING 281,80 AND ON VXV VORTAC R-102 TO VXV VORTAC TO 5000 BEFORE PROCEEDING ON COURSE.
