TITLE 14 CFR PART 97.37**

Bearings, headings, courses, tracks and radials are magnetic. Elevations and altitudes are in feet, MSL. Altitudes are minimum altitudes unless otherwise indicated.
Ceilings are in feet above airport elevation. Distances are in nautical miles. Visibilities are in statute miles or feet RVR unless otherwise indicated.

TAKEOFF MINIMUMS:

RWY 10, STANDARD WITH MINIMUM CLIMB OF 430 FT PER NM TO 8500, OR 2800-3 FOR VCOA.

RWY 28, STANDARD WITH MINIMUM CLIMB OF 365 FT PER NM TO 8300, OR 2800-3 FOR VCOA.

TEXTUAL DEPARTURE PROCEDURES:

VISUAL CLIMB OVER AIRPORT:

RWYS 10, 28 - OBTAIN ATC APPROVAL FOR VCOA WHEN REQUESTING IFR CLEARANCE. CLIMB IN VISUAL CONDITIONS TO CROSS DONA ANA COUNTY INTL JETPORT AT OR ABOVE 6800 BEFORE PROCEEDING ON COURSE.

TAKEOFF OBSTACLE NOTES:

NOTE: RWY 10, BUSHES AND LIGHT SUPPORT STRUCTURE BEGINNING 6 FT FROM DER, 29 FT LEFT OF CENTERLINE, UP TO 7 FT AGL/4115 FT MSL. LIGHT SUPPORT STRUCTURE 9 FT FROM DER, 30 FT RIGHT OF CENTERLINE, 1 FT AGL/4111 FT MSL.

BUSH 159 FT FROM DER, 518 FT RIGHT OF CENTERLINE, 4115 FT MSL.

NOTE: RWY 28, LIGHT SUPPORT STRUCTURE 9 FT FROM DER, 29 FT RIGHT OF CENTERLINE, 4112 FT MSL.

SIGN 31 FT FROM DER, 250 FT LEFT OF CENTERLINE, 4113 FT MSL.

RAILROAD 1335 FT FROM DER, 837 FT LEFT OF CENTERLINE, 23 FT AGL/4148 FT MSL.
