Ceilings are in feet above airport elevation. Distances are in nautical miles. Visibilities are in statute miles or feet RVR unless otherwise indicated.

RWY 12L, 12R: CLIMB ON A HEADING BETWEEN 160 CCW TO 350 FROM DEPARTURE END OF RUNWAY. ALL OTHER COURSES: CLIMB HEADING 115.29 TO INTERCEPT DEN VOR/DME R-275 TO DEN VOR/DME, THENCE...

RWY 21: CLIMB ON A HEADING BETWEEN 160 CCW TO 026 FROM DEPARTURE END OF RUNWAY. ALL OTHER COURSES: CLIMBING LEFT TURN HEADING 044 TO INTERCEPT DEN VOR/DME R-272 TO DEN VOR/DME, THENCE...

DIVERSE HEADINGS AND CLIMB IN HOLD TO 16500 PRIOR TO WESTBOUND (ALL OTHER COURSES) PER FLIGHT CHECK DIRECTION. DIVERSE HEADINGS COULD HAVE BEEN FARTHER WEST BASED ON OBSTACLES HOWEVER FLIGHT CHECK EXPERIENCED SEVERE TURBULENCE APPROACHING MOUNTAIN RANGE AND ADJUSTED THE HEADINGS FARTHER EAST OF MOUNTAIN RANGE.
