Bearings, headings, courses, tracks and radials are magnetic. Elevations and altitudes are in feet, MSL. Altitudes are minimum altitudes unless otherwise indicated.
Ceilings are in feet above airport elevation. Distances are in nautical miles. Visibilities are in statute miles or feet RVR unless otherwise indicated.

TAKEOFF MINIMUMS:

RWY 2: STANDARD.

RWY 20: 300-1 3/4 OR STANDARD WITH MINIMUM CLIMB OF 204 FT PER NM TO 1000, OR ALTERNATIVELY, WITH STANDARD TAKEOFF MINIMUMS AND A NORMAL 200 FT PER NM CLIMB GRADIENT, TAKEOFF MUST OCCUR NO LATER THAN 1200 FT PRIOR TO DER.

RWY 2: CLIMB HEADING 016.46 TO 2200 BEFORE PROCEEDING ON COURSE.

RWY 20: CLIMBING RIGHT TURN HEADING 290.00 TO INTERCEPT CLT VOR/DME R-039 OUTBOUND TO 2100 BEFORE PROCEEDING ON COURSE.
