**RWY 32:** 300 - 1 1/8 OR STANDARD WITH MINIMUM CLIMB OF 312 FT PER NM TO 700 OR ALTERNATIVELY, WITH STANDARD TAKEOFF MINIMUMS AND A NORMAL 200 FT PER NM CLIMB GRADIENT, TAKEOFF MUST OCCUR NO LATER THAN 1800 FEET PRIOR TO DER.
