RWY 5, 23: OBTAIN ATC APPROVAL FOR VCOA WHEN REQUESTING IFR CLEARANCE. CLIMB IN VISUAL CONDITIONS TO CROSS GREATER CUMBERLAND RGNL AIRPORT AT OR ABOVE 3400 BEFORE PROCEEDING ON COURSE.
