RWY 8: 400-2 1/4 OR STANDARD WITH MINIMUM CLIMB OF 223 FT/NM TO 1400 OR ALTERNATIVELY, WITH STANDARD TAKEOFF MINIMUMS AND A NORMAL 200 FT/NM CLIMB GRADIENT, TAKEOFF MUST OCCUR NO LATER THAN 2100 FEET PRIOR TO DER.

1. RAISED RWY 8 TAKEOFF MINIMUMS CLIMB GRADIENT FROM 217 FT/NM TO 223 FT/NM AND INCREASED REDUCED RWY TAKEOFF REQUIREMENT FROM NO LATER THAN 1800 FT FROM DER TO NO LATER THAN 2100 FT FROM DER - TARGETS BUILD VS LEGACY IAPA BUILD. NO CHANGE TO CONTROLLING OBSTRUCTION.
2. UPDATED TAKEOFF OBSTACLE NOTES FOR BOTH RUNWAYS - TARGETS IDENTIFIED MANY NEW LOW CLOSE-IN OBSTACLES.
