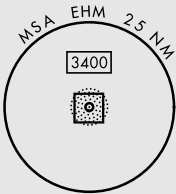

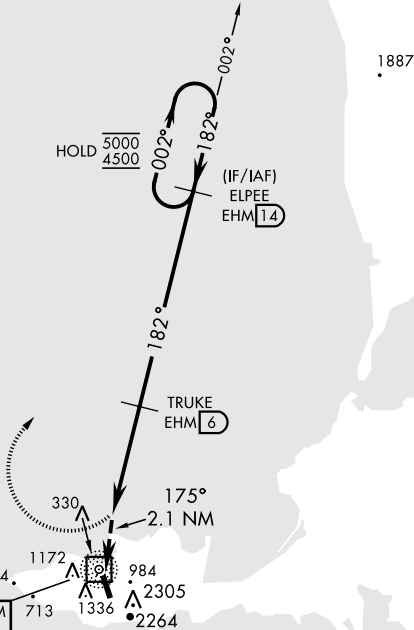

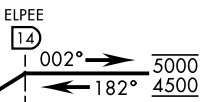


EMERG SAFE ALT 100 NM 7100

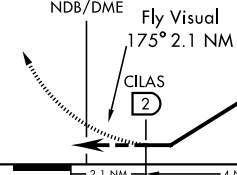

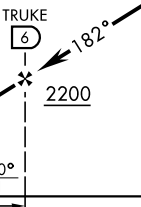

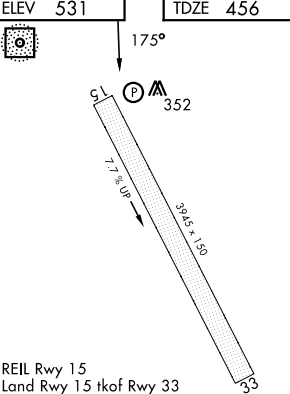
