The Texas Commission on Environmental Quality (TCEQ) has reviewed the above-referenced project and offers the following comments:

In accordance with the general conformity regulations in 40 CFR Part 93, this proposed action was reviewed for air quality impact. The proposed action is located in Bexar County, which is designated nonattainment for the ozone National Ambient Air Quality Standards (NAAQS). Effective November 7, 2022, Bexar County will be classified as moderate nonattainment for the 2015 eight-hour ozone NAAQS. Volatile organic compounds (VOC) and nitrogen oxides (NOX) are precursor pollutants that lead to the formation of ozone. A general conformity demonstration may be required when the total projected direct and indirect VOC or NOX emissions from an applicable action are equal to or exceed 100 tons per year for moderate areas. Based on the information provided to the TCEQ, the emissions from this proposed action are expected to be below the general conformity de minimis threshold and are not anticipated to impact the state implementation plan.

We are in support of the project. The environmental assessment addresses issues related to surface and groundwater quality.

Any debris or waste disposal should be at an appropriately authorized disposal facility.

The Department of the Interior (Department) has reviewed the Environmental Assessment and Section 4(f) Evaluation by the Federal Aviation Administration (FAA) for the San Antonio Airspace Modernization Project in San Antonio Area, Texas. We understand the purpose of the project is to optimize aircraft arrival and departure procedures in the San Antonio Airspace Modernization Project by employing advanced navigational technology. The procedures designed for the San Antonio Airspace Modernization Project would be used by aircraft operating under instrument Flight Rules at the study area airports which include San Antonio International Airport, Kelly Field, New Braunfels National Airport, and Randolph Air Force Base Airfield. The proposed action alternatives are analyzed in the Environmental Assessment.

The Department has reviewed the Section 4(f) Evaluation provided by the FAA for this project which focused on changes in aircraft noise exposure resulting from implementing the Proposed Action. The analysis indicates that the Proposed Action would result in a reportable noise increase at Section 4(f) resources within the General Study Area. The Section 4(f) resources identified within the areas of reportable noise increase consist of recreational parks, cemeteries, historical markers, and private attractions. None of the resources are managed for quiet setting and are in suburban, intensive recreational, or near high traffic areas, and none of the resources have been designated by the estate, local, or federal resource managers as having a high potential value for further noise reduction. Changes in aircraft overflight would occur at altitudes and distances from viewers that would not substantially impair the view or setting of Section 4(f)

resources. Therefore, no constructive use of a Section 4(f) resource associated with the Proposed Action would occur and no significant impact would be anticipated. The Department has no objection to the Section 4(f) evaluation of this project.
