Dear Participant,

The Federal Aviation Administration (FAA) has scheduled a **virtual** meeting of the Aeronautical Charting Meeting (ACM) for **Monday, October 24<sup>th</sup>** through **Thursday, October 27<sup>th</sup>, 2022**.

The Instrument Procedures Group (IPG) meeting is scheduled for a day and a half and will meet from 10:00 AM to 5:00 PM on **Monday, October 24<sup>th</sup>** and from 10:00 AM to 12:00 Noon on **Tuesday, October 25<sup>th</sup>**. The Charting Group meeting is scheduled for two and a half days and will meet from 1:00 PM to 5:00 PM on **Tuesday, October 25<sup>th</sup>** and from 10:00 AM to 5:00 PM **Wednesday, October 26<sup>th</sup>** and **Thursday, October 27<sup>th</sup>**. All times are Eastern Time.

The meeting will be held virtually via Zoom. Details regarding how to participate in the meeting will be provided in a separate email one week before the meeting. The purpose of the ACM is three-fold:

- 1) Identify issues concerning safety and usefulness of aeronautical charts and flight information products/services.
- 2) Discuss and evaluate proposals concerning aeronautical charts and flight information publications, digital aeronautical products, database coding, instrument flight procedures, and instrument flight procedure development, policy, and design.
- 3) Provide an opportunity for government and interested participants to brief and/or discuss new navigation concepts, terminal instrument procedures (TERPS) policy/criteria changes, and charting specifications and methodologies.

The meeting will be a facilitated discussion of new and outstanding topics. The status of an open issue will be reported from meeting to meeting until a resolution is reached, at which point the issue will be closed. Background information of all open and resolved issues for the IPG and Charting Group may be found at the website addresses listed below.
