Subject: RADAR MINIMUMS at Simmons AAF, Fort Liberty, NC (KFBG)

The RADAR MINIMUMS at Simmons AAF, Fort Liberty, NC (KFBG) is cancelled effective October 5, 2023.

The KFBG RADAR MINIMUMS was correctly removed from the SE2RAD.PDF. However, the Index of the US Terminal Procedures Publications, vol SE-2, still shows the RADAR MINIMUMS entry.

Also, the XML (d-TPP_Metafile.xml) and the digital-Terminal Procedures Publication (d-TPP) (2310), effective Oct 5, 2023, do not indicate the RADAR MINIMUMS at Simmons AAF, Fort Liberty, NC (KFBG) as cancelled.
