Subject: Temporary Flight Restriction Formatting

Effective April 5, 2021, Temporary Flight Restrictions will be formatted in accordance with FAAO 7930.2. For multiple years, TFRs have been issued outside of NOTAM Policy. To ensure consistency with FAA Orders, procedures, and systems, these modifications will no longer be made.
