Flight Information

The accuracy and currency of information contained in this guide is uncertain due to the difficulty in obtaining the information and the rapidly changing environment. Aviators should always check with a country's aviation authority or a local aviation handler to determine any specific aircraft airworthiness/equipment and crew/passenger entry requirements.

Entry/Exit Requirements

Entry and exit requirements are for aircraft departing the United States non-stop to country of destination. These requirements do not include any technical stops. Please refer to **Technical Stop** section in **Additional Flight Information** for the country at which the technical stop will be made.

Entry and Exit documentation forms vary from country to country. In general, however, ICAO member countries will accept the following standard ICAO Annex 9 Entry/Exit documents:

- General Declaration
- Passenger Manifest
- Cargo Manifest
- Embarkation/Disembarkation Card
- Certificate of Residual Disinsection

Examples of these documents can be found at [IFIM Home>General Information>International Flying Overview> ICAO Annex 9 Entry/Exit Documents](#). The acceptance of these ICAO documents must be confirmed by the appropriate AIS.

Entry Requirements (Departing the U.S.)

- File an [eAPIS](#) manifest outbound (recommend inbound at this time, too)
- File and activate international flight plan
- Land at a designated airport of entry (AOE) – customs and immigration

The following entry documents are required:

Passengers –

- Valid passport
- [Visa](#)

Pilots – Same as passengers

Aircraft –

- 3 General Declarations (1 for Customs, 1 for Border Control, 1 for Sanitary and Quarantine Post)
- 2 Passenger Manifests (1 for Ground Handling Agent, 1 for Sanitary and Quarantine Post)
- 3 Cargo Manifests (1 for Ground Handling Agent, 1 for Customs, 1 for Sanitary and Quarantine Post)

Exit Requirements (Departing Armenia)

- Same documents as required for entry (see Aircraft above)
- Depart from an AOE
- File [eAPIS](#) manifest if inbound to the U.S.
- File an international flight plan
- Call U.S. Customs at filed U.S. airport of entry

Additional Flight Information

Aircraft Instruments and Equipment

In addition to U.S. aircraft airworthiness and 14 CFR Part 119 certification requirements, most countries adhere to ICAO Annex 6 which defines aircraft instruments, equipment and documents. Exceptions or additions to those rules are listed below for reference only.

Commercial air transport aircraft operating within the Republic of Armenia must adhere to the provision of ANNEX 6 of ICAO– Operation of Aircraft, Part 1 – International Commercial Air Transport – Aeroplane, Chapter 6 (Aeroplane Instruments, Equipment and Flight documents) and Chapter 7 (Aeroplane Communication and Navigation Equipment). Including:

- SSR Transponder
- ACAS II – Commercial aircraft exceeding 5700 kg MTOGW or more than 19 passengers and non-commercial aircraft exceeding 15000 kg MTOGW or more than 30 passengers

- RNAV - all aircraft carrying out IFR flights in the controlled airspace of the Republic of Armenia shall have and use RNAV equipment meeting the following requirements:
 - a system use accuracy equal to or better than 9,26km (5NM) with a 95% containment, thereby meeting the accuracy requirements for RNP-5
 - Average continuity of service of 99.99% of flight time

The following documentation is to be carried on all types of flights:

- Certificate of Registration of the aircraft
- Certificate of Airworthiness of the aircraft
- Permit to use the aircraft radio station
- Journey Log Book
- Flight Operations Manual
- Certificate of the insurance
- Noise Certificate
- Documents about passengers and cargo
- Procedures for pilots-in-command of intercepted aircraft per Annex 2 of ICAO
- A list of visual signals for use by intercepting and intercepted aircraft per Annex 2

On all flight with single-engine and that multi-engine aircraft not capable to maintain the prescribed minimum safe altitude in the event of engine failure, the following emergency equipment shall be carried:

- Signalling equipment:
 - An emergency locator transmitter (ELT); with frequency of 121.500 MHz.
 - Two signal flares of the day and night type
 - A signal sheet (1x1 m) in a reflecting color
 - A knife
 - An electric hand torch.

Technical Stop

There is no specific information in the Armenia AIP regarding Technical Stops other than complying with the Entry Requirements for non-scheduled operation.

Overflight

Non-scheduled flights of foreign civil aircraft transiting the airspace of the Republic of Armenia without landing at the airports of the Republic of Armenia may be conducted without special permission.

Non-scheduled Flights (Charters)

Permission for two or more flights must be applied for at least 14 working days prior to the operation. The required application should be presented to the General Director of Civil Aviation.

For permission to conduct a single non-scheduled flight, application must be made to the General Director of Civil Aviation at least 72 hours before the flight departure time.

Private Flights

There is no specific information in the Armenia AIP regarding Private flights other than complying with the Entry/Exit Requirements above.

Fees

Users should anticipate varying fees for enroute and airport services. Tariff regulations applying to the use of Armenian international aerodromes and Air Navigation charges can be found in the AIC-ARMENIA on the AIP site.

Fuel

Jet A1 is the only fuel available at the AOE's.

Night VFR

The Armenia AIP does not list any restrictions to Night VFR

Public Health Requirements

Aircraft – The IFIM staff is not aware of any health requirements regarding the aircraft.

DOT: [Aircraft Disinsection Requirements](#)

Passenger – In case of suspected infectious disease or any evidence of possible health risks on board of aircraft, the pilot-in-command shall report promptly to Air Traffic Control to ensure, that information is provided to the Sanitary Quarantine Post. On arrival the pilot-in-command shall fill in the Health Part of the Aircraft General Declaration and submit it to the Sanitary Quarantine Post.

The crew members and passengers arriving to the Republic of Armenia from affected areas shall provide to officials of the Sanitary Quarantine Post the appropriate International Certificate of Vaccination or Prophylaxis.
