Entry/Exit Requirements

Entry and exit requirements are for aircraft departing the United States, non-stop to country of destination. These requirements do not include any technical stops. Please refer to **Technical Stop/Overflight** section in **Additional Flight Information** for the country at which the technical stop will be made.

Entry and Exit documentation forms vary from country to country. In general, however, ICAO member countries will accept the following standard ICAO Annex 9 Entry/Exit documents:

- General Declaration
- Passenger Manifest
- Cargo Manifest
- Embarkation/Disembarkation Card
- Certificate of Residual Disinsection

Examples of these documents can be found at [/FIM Home>General Information>International Flying Overview> ICAO Annex 9 Entry/Exit Documents](#). The acceptance of these ICAO documents must be confirmed by the appropriate AIS.

Entry Requirements (Departing the U.S.)

- File an [eAPIS](#) manifest outbound (recommend inbound at this time, too)
- File and activate international flight plan
- Land at a designated airport of entry (AOE) – customs and immigration

The following entry documents are required:

Passengers – Note: immigration requirements are unclear and arbitrarily enforced

- Valid passport
- [Visa](#)
- International Certificate of Vaccination (see CDC for required vaccinations)
- Letter of Invitation (signed by immigration) or proof of hotel reservation
- Embarkation/Disembarkation card

Pilots – Same as passengers

Note: Other pilot/crewmember requirements may be applicable in lieu of those stated. Contact appropriate AIS for further clarification prior to flight.

Aircraft –

- Passenger manifest – 1 for Immigration, 1 for Health
- Health section of general declaration completed, confirming disinfection 30 minutes prior to arrival.

Exit Requirements (Republic of the Congo)

- Embarkation/Disembarkation card
- Depart from an AOE
- File [eAPIS](#) manifest if inbound to the U.S.
- File an international flight plan
- Call U.S. Customs at filed U.S. airport of entry
- Vaccination against any epidemic that occurs while in Congo

Additional Flight Information

Aircraft Instruments and Equipment

U.S. aircraft airworthiness and certification requirements may not meet other countries requirements. It is the responsibility of the pilot to determine if the aircraft meet those requirements.

The items listed below are for pilots' reference to determine if the aircraft meets minimum instrument and equipment requirements of the destination country. Additional equipment may be required to comply with the airspace navigation requirements.

- VHF and HF communication and navigation equipment suitable for the route and landing

Note: If equipped with TCAS, ACAS or transponder, must comply with ICAO standards

Commercial air transport aircraft operating in the member states of ASECNA must be complied with the provisions of ICAO Annex 6 - Operation of aircraft, Part 1- International Commercial Air Transport- Aircraft, Chapter 6 (Aircraft instruments, Equipment and Flight documents) and Chapter 7 (Airplane Communication and Navigation Equipment).

All aircraft assigned to fly over an inhospitable region must be provided with special facilities including signaling, emergency and survival equipments and the manuals to operate such equipment. **The requirements for flight over inhospitable regions are extensive and too numerous to list. One should reference the free on-line AIP for details.**

RVSM

Technical Stop / Overflight

Requests for authorization for technical stops and/or overflights must be submitted to the Ministry in charge of Aviation at least 5 days prior to the operation to:

The following information is required:

- Type of aircraft
- Registration marks
- Nationality
- Owner or aircraft operator
- Address of Owner or aircraft operator
- Name, surname of the pilot and nationality (1)
- Crew member
- Number of passengers
- Flight purpose
- Dates and flight routes

Note: When it concerns a private aircraft, the pilot will provide his place and date of birth.

Non-scheduled Flights (Charters)

The IFIM Staff is not aware of any requirements or restrictions.

Private Flights

The Asecna/Congo AIP only refers to Private flights relating to technical stops and overflights. (see Technical Stops/Overflights)

Float Planes

The IFIM Staff is not aware of any Float Plane requirements or restrictions.

Light Sport Aircraft

The IFIM Staff is not aware of any Light Sport Aircraft requirements or restrictions.

Fees

There are variable fees for landing, runway lighting facilities, passenger services, parking, fueling, security and air navigation. Please refer to the free on-line AIP for details.

Fuel

Jet A1, only, is available at both AOE's.

Night VFR

The VFR flights are not allowed over and above the flight level 150.

VFR flights are not authorized at night, which means, during the period that begins 15 minutes after the sunset and finishes 15 minutes before the sunrise.

Island Hopping

The IFIM Staff is unaware of any Island Hopping requirements or restrictions

Country Specific Travel Information

Public Health

Aircraft – The aircraft may land under the condition that it has been disinfected approximately 30 minutes before its arrival on the aerodrome. The application of this measure must be properly recorded in the Health Section of the General Declaration

Pilots should refer to the DOT website below for any current requirements.

Passengers – Yellow fever vaccination dating more than 10 days and less than 10 years required for all people aged of more than 1 year with the exception of passengers staying in Congo less than 15 days and coming from a non-infected zone.
