## Flight Information

The accuracy and currency of information contained in this guide is uncertain due to the difficulty in obtaining the information and the rapidly changing environment. Aviators should always check with a country's aviation authority or a local aviation handler to determine any specific aircraft airworthiness/equipment and crew/passenger entry requirements.

### Entry/Exit Requirements

Entry and exit requirements are for aircraft departing the United States non-stop to country of destination. These requirements do not include any technical stops. Please refer to **Technical Stop** section in **Additional Information** for the country at which the technical stop will be made.

Entry and Exit documentation forms vary from country to country. In general, however, ICAO member countries will accept the following standard ICAO Annex 9 Entry/Exit documents:

- General Declaration
- Passenger Manifest
- Cargo Manifest
- Embarkation/Disembarkation Card
- Certificate of Residual Disinsection

Examples of these documents can be found at [IFIM Home>General Information>International Flying Overview> ICAO Annex 9 Entry/Exit Documents](#). The acceptance of these ICAO documents must be confirmed by the appropriate AIS.

### Entry Requirements (Departing the U.S.)

- File an [eAPIS](#) manifest outbound (recommend inbound at this time, too)
- File and activate international flight plan
- Land at a designated airport of entry (AOE) – customs and immigration

The following entry documents are required:

#### *Passengers –*

- Passport
- [Visa](#) - required for U.S. Citizens

- International Vaccination record (WHO card)
- Yellow fever Vaccination (WHO Card)
- ICAO Embarkation/Disembarkation card

*Crew* – Same as passengers

*Note:* Other requirements may be applicable in lieu of those stated. Contact appropriate AIS for further clarification prior to flight

*Aircraft* –

- General Declaration - 1 copy for Customs
- Passenger Manifest - 1 copy for Customs
- Cargo Manifest - 2 copies for Customs

*Note:* If no passengers or cargo are loaded or unloaded, only the General Declaration is required

#### **Exit Requirements (Departing Guinea)**

- General Declaration - 1 copy for Customs, 1 for Immigration, 1 for Health
- Passenger Manifest - 1 copy for Customs, 1 for Immigration, 1 for Health
- Cargo Manifest - 2 copies for Customs, 1 for Immigration, 1 for Health
- ICAO Embarkation/Disembarkation card
- Depart from an AOE
- File [eAPIS](#) manifest if inbound to the U.S.
- File an international flight plan
- Call U.S. Customs at filed U.S. airport of entry

### **Additional Flight Information**

#### **Aircraft Instruments and Equipment**

U.S. airworthiness and certification requirements may not meet other country requirements. It is the responsibility of the pilot to determine if the aircraft meets those requirements.

The items listed below are for the pilot's reference to determine if the aircraft meets the minimum instrument and equipment requirements of the destination country. Additional equipment may be required to comply with the airspace navigation requirements.

Commercial air transport aircraft operating in Guinea must adhere to the provisions of ICAO Annex 6 – Operation of Aircraft, Part 1 – International Commercial Air Transport – Aeroplanes, Chapter 6 (Aeroplanes Instruments, Equipment and Flight Documents) and Chapter 7 (Aeroplane Communication and Navigation Equipment)

#### **RVSM**

[Domestic and International RVSM](#) guidance is provided on the IFIM Home Page. Click on the **Air Traffic** tab and select **Separation Standards** from the drop down list.

### **Technical Stop/Overflight**

Owners or aircraft operators engaged in private services who intend to land or make a non-traffic stop may be required by Public Health authorities to conduct a second spraying of the aircraft, on the ground.

### **Non-scheduled Flights (Charters)**

Prior permission is not required provided the aircraft is registered in a state that grants the same privilege to Guinean aircraft. It must, however, telex a message to the Department of Civil Aviation at least 3 days prior to the flight:

### **Private Flights**

Advance Notification of arrival is required.

### **Float Planes**

The IFIM Staff is not aware of any Float Plane requirements or restrictions.

### **Light Sport Aircraft**

The IFIM Staff is not aware of any Light Sport Aircraft requirements or restrictions.

### **Fees**

Users should anticipate varying fees, based on aircraft weight, for landing, parking, hangarage, storage, passenger services (departure fee), infrastructure fee, security, after hour surcharges and air navigation (see contact for **Enroute and Airport Charges** in Designated Authorities).

### **Fuel**

Conakry airport only offers Jet A1 fuel.

### **VFR/Night VFR**

VFR flights are not permitted within the Roberts Control Zone.

### **Aeronautical Charts**

Aeronautical charts may be obtained from the AIS office (see Aeronautical Information Services listed under Designated Authorities).

### Pets

Health certificates or related documents are required in respect to animals. A certificate of anti-rabic vaccination is required for dogs and cats. For the exportation of animals, a health certificate must be delivered by animal quarantine services few days before the trip. A health booklet containing pertinent health information must also accompany the animal.
