The accuracy and currency of information contained in this guide is uncertain due to the difficulty in obtaining the information and the rapidly changing environment. Aviators should always check with a country's aviation authority or a local aviation handler to determine any specific aircraft airworthiness/equipment and crew/passenger entry requirements.

### **Entry/Exit Requirements**

Entry and exit requirements are for aircraft departing the United States non-stop to country of destination. These requirements do not include any technical stops. Please refer to **Technical Stop** section in **Additional Flight Information** for the country at which the technical stop will be made.

Entry and Exit documentation forms vary from country to country. In general, however, ICAO member countries will accept the following standard ICAO Annex 9 Entry/Exit documents:

- → General Declaration
- → Passenger Manifest
- Cargo Manifest
- → Embarkation/Disembarkation Card
- → Certificate of Residual Disinsection

Examples of these documents can be found at <u>IFIM Home>General Information>International</u> <u>Flying Overview> ICAO Annex 9 Entry/Exit Documents</u>. The acceptance of these ICAO documents must be confirmed by the appropriate AIS.

### **Entry Requirements (Departing the U.S.)**

- → File an <u>eAPIS</u> manifest outbound (recommend inbound at this time, too).
- → File and activate international flight plan.
- → For ease of reference, Flight permission number granted to non-scheduled international flights should be inserted in Item 18 of the Flight plan with following format: RMK / IRFPN /...(19 characters).
- → Land at a designated airport of entry (AOE) customs and immigration.

The following entry documents are required:

### **Passengers**

- → Valid passport (valid for 6 months beyond departure date)
- → Visa

Pilots - Same as passengers

*Note:* Other pilot/crewmember requirements may be applicable in lieu of those stated. Contact appropriate AIS for further clarification prior to flight.

#### Aircraft

- → 1 General Declaration (1 Health).
- → 2 Passenger Manifest (1 CAO, 1 Immigration).
- → 2 or 3 Cargo Manifest (1 CAO, 1 Customs, 1\* Health).

Note: CAO (Civil Aviation Organization)

\* If live animals, plants, foodstuffs or other perishable foods are unloaded.

#### Exit Requirements (Departing Iran)

- → Depart from an AOE
- → File eAPIS manifest if inbound to the U.S.
- → File an international flight plan
- → Call U.S. Customs at filed U.S. airport of entry
- → 2 General Declarations (2 Customs).
- → 2 Passenger Manifest (1 CAO, 1 Customs).
- → 2 Cargo Manifest (1 CAO, 1 Customs).

### Additional Flight Information

All flights before entering Iran ADIZ (Tehran FIR) are required to contact the appropriate defense radar station, as specified below, on **127.800 MHZ** or **135.100 MHZ**, at least 10 minutes prior to entering Tehran FIR, for the purpose of military identification and avoidance of interception especially for those aircraft entering via Persian Gulf and Oman sea

#### Aircraft Instruments and Equipment

U.S. aircraft airworthiness and certification requirements may not meet other countries requirements. It is the responsibility of the pilot to determine if the aircraft meet those requirements.

Iran requires that aircraft shall be equipped with suitable instruments and with navigation equipment appropriate to the route to be flown.

Commercial air transport aircraft operating in Iran must adhere to the provisions of ICAO Annex 6 Departion of Aircraft, Part I International Commercial Air Transport Aeroplanes, Chapter 6 (Aeroplane Instruments, Equipment and Flight Documents) and Chapter 7 (Aeroplane Communication and Navigation Equipment).

#### **RVSM**

<u>Domestic and International RVSM</u> guidance is provided on the IFIM Home Page. Click on the **Air Traffic** tab and select **Separation Standards** from the drop down list.

### **Technical Stop / Overflight**

International flights into, from or over Islamic Republic of Iran territory (Tehran FIR) shall be subject to the current Islamic Republic of Iran regulations relating to civil aviation. These regulations correspond in all essentials to the Standards and Recommended Practices contained in Annex 9 to the Convention on International Civil Aviation.

# Non-Scheduled Flights (Charters)

If an operator intends to carry out a (series of) non-scheduled flight(s) in transit across, or making non-traffic stops in, the territory of Islamic Republic of Iran (Tehran FIR), it is necessary for the operator to obtain prior permission from Flight Permission Unit at least twenty-four hours in advance. (see designated authorities)

#### **Private Flights**

Same requirements as for Non-Scheduled Flights.

### **Float Planes**

The IFIM staff is not aware of any Float Plane requirements or restrictions.

#### **Light Sport Aircraft**

The IFIM staff is not aware of any Light Sport Aircraft requirements or restrictions.

#### **Fees**

Users should anticipate air navigation fees, landing fees, lighting fees, aborted takeoff fees, parking fees, passenger service fees, terminal facility fees and security fees. All Non-scheduled international flights operating in the territorial airspace and airports of the Islamic republic of Iran - regardless of their operational reasons - are required to pay the aerodrome and air navigation services charges in cash. The payment should be made in U.S. dollar, Euro or GBP due to unavailability of automated banking facilities (credit card).

Jet A1 is available at OIKB, OIFM, OIMM, OISS, OITT, OIIE, OIII, OIZH 100 LL is available at OIFM, OIMM, OISS, OITT, OIII

### VFR/Night VFR

VFR flights may be authorized to operate within the aerodrome traffic zone or traffic pattern during night subject to prior coordination with the appropriate ATS authority.

Night VFR flights shall not be operated. Night means 15 MIN after sunset and 15 MIN before sunrise.

### **Island Hopping**

The IFIM staff is not aware of any Island Hopping requirements or restrictions.

# **Country Specific Travel Information**

### **Public Health Requirements**

Aircraft -

Aircraft arriving from foreign countries may land at any international aerodrome in Islamic Republic of Iran provided that the aircraft has been disinfected approximately thirty minutes before arrival at the aerodrome. This action must be properly recorded in the Health Section of the General Declaration. The record must include the name of the insecticide used.

Passengers -

Disembarking passengers are not required to present vaccination certificates except when coming directly from an area infected with cholera, yellow fever or smallpox.

On departure, no health formalities are required.
