# **Entry/Exit Requirements**

Entry and exit requirements are for aircraft departing the United States non-stop to country of destination. These requirements do not include any technical stops. Please refer to **Technical Stop** section in **Additional Flight Information** for the country at which the technical stop will be made.

Entry and Exit documentation forms vary from country to country. In general, however, ICAO member countries will accept the following standard ICAO Annex 9 Entry/Exit documents:

- → General Declaration
- → Passenger Manifest
- → Cargo Manifest
- → Embarkation/Disembarkation Card
- → Certificate of Residual Disinsection

Examples of these documents can be found at <u>IFIM Home>General Information>International</u> <u>Flying Overview> ICAO Annex 9 Entry/Exit Documents</u>. The acceptance of these ICAO documents must be confirmed by the appropriate AIS.

# **Entry Requirements (Departing the U.S.)**

- → File an <u>eAPIS</u> manifest outbound (recommend inbound at this time, too)
- → File and activate international flight plan
- → Land at a designated airport of entry (AOE) customs and immigration

The following entry documents are required:

#### Passengers -

- → Valid passport
- → Visa (only required for stays over 90 days)
- → Documentation stating purpose of visit (recommended)

#### Pilots - Same as passengers

*Note:* Other pilot/crewmember requirements may be applicable in lieu of those stated. Contact appropriate AIS for further clarification prior to flight.

### Aircraft -

- → General Declaration 1 for Customs, 1 for Immigration, 1 for Health
- → Passenger Manifest 1 for Customs, 1 for Immigration, 1 for Health
- → Cargo Manifest 2 for Customs, 1 for Health
- → Insurance for damage outside the aircraft resulting from its use

### **Exit Requirements (Departing Kosovo)**

- → General Declaration 1 for Immigration, 1 for Health
- → Passenger manifest 1 for Customs, 1 for Immigration, 1 for Health
- → Cargo Manifest 2 for Customs, 1 for Health
- → Depart from an AOE
- → File <u>eAPIS</u> manifest if inbound to the U.S.
- > File an international flight plan
- → Call U.S. Customs at filed U.S. airport of entry

# **Additional Flight Information**

Note: All airspace over Kosovo remains closed above FL285.

### **Aircraft Instruments and Equipment**

U.S. aircraft airworthiness and certification requirements may not meet other countries requirements. It is the responsibility of the pilot to determine if the aircraft meet those requirements.

The items listed below are for pilots' reference to determine if the aircraft meets minimum instrument and equipment requirements of the destination country. Additional equipment may be required to comply with the airspace navigation requirements.

Commercial air transport aircraft operating in Kosovo must adhere to the provision of ICAO Annex 6 – *Operation of Aircraft*, Part I – *International Commercial Air Transport* – *Aeroplanes*, Chapter 6 (Aeroplane Instruments, Equipment and Flight Documents) and Chapter 7 (Aeroplane Communication and Navigation Equipment).

All standards of ICAO Annex 6, Part II, are applicable.

#### **RVSM**

### Non-scheduled Flights (Charters)

Air carriers planning to operate non scheduled services to and from Kosovo shall submit the documents listed in the free on-line Kosov AIP, section General 1.2, page 1.2-2, paragraph 1.2.3 Non-scheduled Flights.

### **Private Flights**

Private flights shall submit to the Ministry of Transport and Communication (MTC) the documents listed in the free on-line Kosov AIP, section, General 1.2, page 1.2-2, paragraph 1.2.4.

An application for a private flight must be received by MTC at least 3 business days before the date of the flight. The request shall be sent to the following address:

#### **Float Planes**

### **Light Sport Aircraft**

The IFIM Staff is not aware of any Light Sport Aircraft requirements or restrictions.

#### Fees

#### Fuel

Jet A1 is the only fuel available at Pristina International Airport.

### VFR/Night VFR

VFR flight is not permitted between sunset and sunrise or above FL 195.
