Special Provisions for Šiauliai International Airport

Permits for all civil and military flights shall be obtained from the Administration of Aviation Base. Prior permission request (see AIC A04/12) shall be sent by Telefax: +370 5 211 38 98, AFS: EYSAZPX or E-mail: ABAOB@mil.lt not later than 24 HRs before the planned flights. Permits for flights at weekend and on holidays shall be obtained on the last working day of week. Inquire by Tel. +370 41 59 21 04.

Entry/Exit Requirements

Entry and exit requirements are for aircraft departing the United States non-stop to country of destination. These requirements do not include any technical stops. Please refer to **Technical Stop** section in **Additional Information** for the country at which the technical stop will be made.

Entry and Exit documentation forms vary from country to country. In general, however, ICAO member countries will accept the following standard ICAO Annex 9 Entry/Exit documents:

- General Declaration
- Passenger Manifest
- Cargo Manifest
- Embarkation/Disembarkation Card
- Certificate of Residual Disinsection

Examples of these documents can be found at [/FIM Home>General Information>International Flying Overview> ICAO Annex 9 Entry/Exit Documents](#). The acceptance of these ICAO documents must be confirmed by the appropriate AIS.

Entry Requirements (Departing the U.S.)

File an [eAPIS](#) manifest outbound (recommend filing inbound at this time)
File and activate international flight plan
Land at an AOE

The following entry documents are required:

Passengers –

- Valid passport
- [Visa](#) (Not required for U.S. citizen for tourist or business purposes for 90 days)

Pilots – Same as for Passengers

Note: Other pilot/crewmember requirements may be applicable in lieu of those stated. Contact appropriate AIS for further clarification prior to flight.

Aircraft-

- General Declaration - ! copy to Customs, 1 copy to Immigration, 1 copy to Medical Officer
- Passenger Manifest - - ! copy to Customs, 1 copy to Immigration, 1 copy to Medical Officer
- Cargo Manifest - ! copy to Customs, 1 copy to Immigration, 1 copy to Medical Officer

Note: If no passengers are embarking (disembarking) and no articles are laden (unladen), no aircraft document except copy of the General Declaration need be submitted to the above authorities.

- Examination of aircraft by a Public Health Officer
- Meet noise level requirements as established by the Ministry of Transport
- Valid civil liability insurance certificate
- Noise certificate
- Procedures, as prescribed in ICAO Annex 2, for intercepted aircraft

Exit Requirements (Departing Lithuania)

- Same documents as required for Entry (see *Aircraft-* above)
- Depart from an AOE
- File [eAPIS](#) manifest if inbound to the U.S.
- File an international flight plan
- Call U.S. Customs at filed U.S. airport of entry

Additional Flight Information

Aircraft Instruments and Equipment

U.S. aircraft airworthiness and certification requirements may not meet other countries requirements. It is the responsibility of the pilot to determine if the aircraft meet those requirements.

The items listed below are for pilots' reference to determine if the aircraft meets minimum instrument and equipment requirements of the destination country. Additional equipment may be required to comply with the airspace navigation requirements

- Two way, 8.33 kHz radio spacing above FL195
- Mode C Transponder
- A+C Mode SSR transponder - when flying above prohibited areas
- ELT
- RNAV-5 - From FL095 and up.
 - ACAS II - for turbine-engine with two engines or more aircraft, having a maximum take-off mass exceeding 5700 kg, or a maximum approved passenger seating configuration of more than 19, from 1st of January 2005

Flights with single-engine and multi-engine aircraft not capable to maintain the prescribed minimum safe altitude in the event of engine failure, the following emergency equipment shall be carried:

Signaling equipment

- An emergency locator transmitter (SERF), its frequency is 121.500 MHz
- Four red signal cartridges and the means of firing them
- A signal mirror
- Two chemical dye for water and snow
- An electric hand torch

Survival equipment

- A compass
- A knife
- Two boxes of matches in waterproof containers

Commercial air transport aircraft operating in Lithuania must adhere to the provisions of Annex 6 Operation of Aircraft, Part I - International Commercial Air Transport - Airplane, Chapter 6 (Airplane Instruments, Equipment and Flight Documents) and Chapter 7 (Airplane Communication and Navigation Equipment).

RVSM

Overflight / Technical Stop

Private Flights

No permit for flights of foreign aircraft of general aviation into and from the territory of the Republic of Lithuania is required.

Non-scheduled Flights

No special permission shall be required for an ICAO member, non-scheduled, transit flight without landing on the territory of the Republic of Lithuania or with stops for non-traffic purposes.

Non-Scheduled Commercial Flights (Charters)

Application for a permit to land shall be submitted no later than 2 working days prior to the flight to:

An application for a series of more than 4 flights shall be submitted no later than 5 working days before the flight.

Private Flights

No permit for flights of foreign aircraft of general aviation into and from the territory of the Republic of Lithuania is required.

Fees

Users should anticipate varying fees for landing, passenger services, parking, security and leading (follow me) service.

Air navigation fees shall be assessed for route charges and terminal charges.

Float Planes

The IFIM Staff is not aware of any Float Plane requirements or restrictions.

Light Sport Aircraft

The IFIM Staff is not aware of any Light Sport Aircraft requirements or restrictions.

Fuel

EYKA and EYPA have Jet A1 and Avgas available. EYSA and EYVI only offer Jet A1.

Night VFR

Night VFR flights from sunset to sunrise are operated:

- ➔ VFR night flights are permitted only from an aerodrome in possession of the certificate of approval, confirming that the aerodrome is suitable for night operations.
- ➔ VFR night flights are permitted in the uncontrolled airspace, provided visibility is not less than 8 KM (for helicopters – 5 KM), horizontal distance to clouds is not less than 1500 M and vertical distance to clouds is not less than 1000 FT (300 M)

- VFR night flights are permitted in the controlled airspace, provided visibility is not less than 8 KM at or above FL100 and not less than 5 KM below FL100 (for helicopters – not less than 3 KM). Ceiling is not less than 1500 FT (450 M)

VFR

The VFR flights above the flight level 200 shall be prohibited without a permission issued by the State enterprise “Oro navigacija”. (See Designated Authorities)

Island Hopping

The IFIM Staff is not aware of any Island Hopping requirements or restrictions.
