## Flight Information

The accuracy and currency of information contained in this guide is uncertain due to the difficulty in obtaining the information and the rapidly changing environment. Aviators should always check with a country's aviation authority or a local aviation handler to determine any specific aircraft airworthiness/equipment and crew/passenger entry requirements.

### Entry/Exit Requirements

Entry and exit requirements are for aircraft departing the United States non-stop to country of destination. These requirements do not include any technical stops. Please refer to **Technical Stop** section in **Additional Flight Information** for the country at which the technical stop will be made.

Entry and Exit documentation forms vary from country to country. In general, however, ICAO member countries will accept the following standard ICAO Annex 9 Entry/Exit documents:

- General Declaration
- Passenger Manifest
- Cargo Manifest
- Embarkation/Disembarkation Card
- Certificate of Residual Disinsection

Examples of these documents can be found at [IFIM Home>General Information>International Flying Overview> ICAO Annex 9 Entry/Exit Documents](#). The acceptance of these ICAO documents must be confirmed by the appropriate AIS.

### Entry Requirements (Departing the U.S.)

- File an [eAPIS](#) manifest outbound (recommend inbound at this time, too)
- File and activate international flight plan
- Flight plan shall be sent to Macua tower, Guangzhou ACC, Zhuhai APP and Hong Kong ACC
- Land at a designated airport of entry (AOE) – customs and immigration

The following entry documents are required:

#### *Passengers –*

- Valid passport (valid for at least 30 days after departure)
- [Visa](#) (may visit up to 30 days without a visa)

#### *Pilots – Same as passengers*

#### *Aircraft –*

- Traffic Form (General Declaration)- 1 for Customs, 1 for immigration, 1 for Airport management
- Passenger manifest – 1 for Immigration
- Crew List – 1 for Immigration
- Certificates of Registration and Airworthiness
- Licenses of the flight crew
- Journey logbook (flight log)
- Compulsory third party insurance (Liability amount depends on aircraft weight)

#### **Exit Requirements (Departing Macau)**

- Depart from an AOE
- File [eAPIS](#) manifest if inbound to the U.S.
- File an international flight plan
- Call U.S. Customs at filed U.S. airport of entry
- Departure Documents – Same as Aircraft entry documents

### **Additional Flight Information**

#### **Aircraft Instruments and Equipment**

U.S. aircraft airworthiness and certification requirements may not meet other countries requirements. It is the responsibility of the pilot to determine if the aircraft meet those requirements.

The items listed below are for pilots' reference to determine if the aircraft meets minimum instrument and equipment requirements of the destination country. Additional equipment may be required to comply with the airspace navigation requirements.

Commercial air transport aircraft operating in Macau must adhere to the provisions of Annex 6 - Operation of Aircraft, Part I, Chapter 6 (Aeroplane Instruments, Equipment, and Flight Documents) and Chapter 7 (Aeroplane Communication and Navigation Equipment)

- Private aircraft, regardless of weight, are required to have full navigational ability:
- Two-way VHF radio with appropriate frequencies;
- VOR;
- DME
- Mode C Transponder

#### **RVSM**

[Domestic and International RVSM](#) guidance is provided on the IFIM Home Page. Click on the **Air Traffic** tab and select **Separation Standards** from the drop down list.

### **Technical Stop / Overflight**

The captain of an aircraft which lands in Macau International Airport for non-traffic purposes will, before departure, be required to sign at the Airport Dispatch Office, a certificate to the effect that the flight is not subject to a permit.

### **Non-scheduled Flights (Charters)**

Non-scheduled flight requires a permit from the President of the Civil Aviation Authority. After authorization being granted, the operator shall send the respective Flight Plan to Macau Tower, Guangzhou ACC, Zhuhai APP and Hong Kong ACC.

### **Private Flights**

For administrative purposes, a 72 hours notification is required for private non-revenue flights (Three working days in advance).

Private aircraft must employ the services of a recognized ground handling agent and shall conform with the following procedures.

The pilot shall inform Guangzhou ACC, Zhuhai APP and Hong Kong ACC of the authorization for the use of Macau International Airport.

### **Float Planes**

The IFIM Staff is not aware of any Float Plane requirements or restrictions.

### **Light Sport Aircraft**

The IFIM Staff is not aware of any Light Sport Aircraft requirements or restrictions.

### **Fees**

Users should anticipate variable fees for landing, parking and passenger fees. There are no air navigation fees.

### **Fuel**

Jet A1 and Avgas are available at Macau International airport.

### **Night VFR**

International Commercial Air Transport - Aeroplanes) (9th Edition, Amendment 35): Single pilot, commercial operations are not permitted at night.

“All flights within Macau ATZ, notified for the purposes of Rule 20 of the Rules of the Air Traffic Control, Schedule 11 to the Air Navigation Regulation of Macao, are subject to Instrument Flight Rules in all weather conditions.” [sic]

### **Island Hopping**

The IFIM Staff is not aware of any Island Hopping requirements or restrictions.
