# Flight Information

The accuracy and currency of information contained in this guide is uncertain due to the difficulty in obtaining the information and the rapidly changing environment. Aviators should always check with a country's aviation authority or a local aviation handler to determine any specific aircraft airworthiness/equipment and crew/passenger entry requirements.

# **Entry/Exit Requirements**

Entry and exit requirements are for aircraft departing the United States non-stop to country of destination. These requirements do not include any technical stops. Please refer to **Technical Stop** section in **Additional Information** for the country at which the technical stop will be made.

Entry and Exit documentation forms vary from country to country. In general, however, ICAO member countries will accept the following standard ICAO Annex 9 Entry/Exit documents:

- → General Declaration
- → Passenger Manifest
- → Cargo Manifest
- → Embarkation/Disembarkation Card
- → Certificate of Residual Disinsection

The acceptance of these ICAO documents must be confirmed by the appropriate AIS.

#### **Entry Requirements (Departing the U.S.)**

- → File an eAPIS manifest outbound (recommend inbound at this time, too)
- → File and activate international flight plan
- → Land at a designated airport of entry (AOE) customs and immigration

The following entry documents are required:

## Passengers -

- → Passport
- → Visa not required for U.S. citizens for stays of less than 90 days
- → Visitor's Permit issued at airport, valid for 30 days, can be renewed twice for an additional 30 days each time (fee required)
- > Yellow fever vaccination certificate if arriving from any infected area
- → Cholera vaccination certificate for all passengers and crew over 1 year of age

## Crew - Same as passengers

Note: Other requirements may be applicable in lieu of those stated. Contact appropriate AIS for further clarification prior to flight

#### Aircraft -

#### Non-scheduled flights:

- → General Declaration 2 copies for Customs (Malawi customs Form Nr 2)
- Passenger Manifest 1 for Immigration
- → Cargo Manifest 1 for Immigration
- → Airway Bills 1 for Immigration

#### Private flights:

- → General Declaration 4 copies for Immigration, 1 copy for customs
- → Cargo Manifest 1 copy for customs (for items other than personal effects)

## **Exit Requirements (Departing Malawi)**

#### Non-scheduled flights:

- > Passenger Manifest 4 for Immigration
- > Cargo Manifest 1 for Customs
- → Airway Bills 1 for Customs
- → Report of Departure Malawi Customs Form 7 2 copies for Customs
- → Depart from an AOE
- → File <u>eAPIS</u> manifest if inbound to the U.S.
- → File an international flight plan
- → Call U.S. Customs at filed U.S. airport of entry

#### Private flights:

→ Report of Departure - Malawi Customs Form Nr 7 - 2 copies for Customs

# Additional Flight Information

#### **Aircraft Instruments and Equipment**

U.S. airworthiness and certification requirements may not meet other country requirements. It is the responsibility of the pilot to determine if the aircraft meets those requirements.

The items listed below are for the pilot's reference to determine if the aircraft meets the minimum instrument and equipment requirements of the destination country. Additional equipment may be required to comply with the airspace navigation requirements.

All aircraft operating within Malawi shall carry radio communications and navigation equipment as laid down in the Seventh schedule to the Aviation (Air Navigation) Regulations, 1970 as amended.[sic]

# Non-scheduled Flights (Charters)

Operators wishing to overfly or land in Malawi must apply to the Director of Civil Aviation for permission to carry out such operation not less than forty-eight hours (48hrs) prior to the intended operation.

#### **Private Flights**

Advance notification of arrival. Same requirements as for non-scheduled flights, above.

#### Float Planes

The IFIM Staff is not aware of any Float Plane requirements or restrictions.

#### **Light Sport Aircraft**

The IFIM Staff is not aware of any Light Sport Aircraft requirements or restrictions.

#### Fees

Users should anticipate varying fees for landing, parking, hangarage, long term storage, passenger services (departure fee), extended hours and air navigation.

#### **Fuel**

Jet A1 and Avgas are available at FWCL and FWKI. There is no fuel available at the remaining AOEs.

#### VFR/Night VFR

VFR flight shall not be operated above FL150 or at transonic or supersonic speeds.

VFR flights shall not be operated at night except as a Special VFR flight with the appropriate clearance.

#### **Aeronautical Charts**

The approach charts and other maps and charts published in the AIP may be obtained from the Department of Civil Aviation (see Designated Authorities).

# **Public Health Requirements**

Aircraft – Aircraft arriving from any locally infected Yellow Fever area (as promulgated by the World Health Organization) will be sprayed on arrival by the Public Health authorities, unless the pilot-in-command certifies that the aircraft was properly disinfected immediately prior to taxiing out at the last point of departure within such locally infected area.
