Flight Information

The accuracy and currency of information contained in this guide is uncertain due to the difficulty in obtaining the information and the rapidly changing environment. Aviators should always check with a country's aviation authority or a local aviation handler to determine any specific aircraft airworthiness/equipment and crew/passenger entry requirements.

Airports of Entry

[DRZA – AGADÈZ/MANU DAYAK](#) (Scheduled Flights Only)
[DRRN – NIAMEY/DIORI HAMANI](#) (Scheduled Flights Only)
[DRZR – ZINDER](#) (Scheduled Flights Only)

Although the above airports publish “Scheduled Flights Only” they do indicate that Customs, Immigration and Public Health are available on request

Entry/Exit Requirements

Entry and exit requirements are for aircraft departing the United States non-stop to country of destination. These requirements do not include any technical stops. Please refer to **Technical Stop** section in **Additional Flight Information** for the country at which the technical stop will be made.

Entry and Exit documentation forms vary from country to country. In general, however, ICAO member countries will accept the following standard ICAO Annex 9 Entry/Exit documents:

- General Declaration
- Passenger Manifest
- Cargo Manifest
- Embarkation/Disembarkation Card
- Certificate of Residual Disinsection

Examples of these documents can be found at [IFIM Home>General Information>International Flying Overview> ICAO Annex 9 Entry/Exit Documents](#). The acceptance of these ICAO documents must be confirmed by the appropriate AIS.

Entry Requirements (Departing the U.S.)

- File an [eAPIS](#) manifest outbound (recommend inbound at this time, too)
- File and activate international flight plan
- Land at a designated airport of entry (AOE) – customs and immigration

The following entry documents are required:

Passengers –

- Valid passport
- [Visa](#) - required for U.S. Citizens
- Disembarkation Card
- Yellow Fever Vaccination Certificate

Pilots – Same as passengers

Note: Other pilot/crewmember requirements may be applicable in lieu of those stated. Contact appropriate AIS for further clarification prior to flight.

Aircraft –

- General Declaration – 1 for Customs, 1 for Immigration and 1 for Health
- Passenger Manifest – 1 for Immigration and 1 for Public Health
- Health section of General Declaration completed, confirming disinfection 30 minutes prior to arrival.
- Cargo Manifest - 1 for Customs, (not required for Technical Stop)

Exit Requirements (Departing Niger)

- Same documents as required for Entry (see Aircraft- above)
- Passport
- Embarkation Card

- Depart from an AOE
- File [eAPIS](#) manifest if inbound to the U.S.
- File an international flight plan
- Call U.S. Customs at filed U.S. airport of entry

Additional Flight Information

Aircraft Instruments and Equipment

U.S. aircraft airworthiness and certification requirements may not meet other countries requirements. It is the responsibility of the pilot to determine if the aircraft meet those requirements.

The items listed below are for pilots' reference to determine if the aircraft meets minimum instrument and equipment requirements of the destination country. Additional equipment may be required to comply with the airspace navigation requirements.

- VHF and HF communication and navigation equipment suitable for the route and landing

Note: If equipped with TCAS, ACAS or transponder, must comply with ICAO standards

Commercial (Non-scheduled) air transport aircraft operating in Niger must comply with the provisions of ICAO Annex 6 - Operation of aircraft, Part 1- International Commercial Air Transport- Aircraft, Chapter 6 (Aircraft instruments, Equipments and Flight documents) and Chapter 7 (Airplane Communication and Navigation Equipment). Additionally, they must have communications (VHF and HF), navigation (en-route and landing) equipment and as well as surveillance and collision avoidance facilities. This equipment must comply with the arrangements of ICAO Annex 10.

All aircraft assigned to fly over an inhospitable region must be provided with special facilities including signaling, emergency and survival equipments and the manuals to operate such equipment. **The requirements for flight in inhospitable regions are extensive and too numerous to list. One should reference the free on-line AIP for details.**

RVSM

[Domestic and International RVSM](#) guidance is provided on the IFIM Home Page. Click on the **Air Traffic** tab and select **Separation Standards** from the drop down list.

Technical Stop / Overflight

A request for authorization, for overflight or technical stop, must be submitted to the Ministry of Public Works, Transport and Urbanism at least 4 days in advance of flight.

For all overflights of Niger territory with or without a stopover, all aircraft must contract a third party insurance policy, or to provide a guaranty, in accordance with the legislation in force.

All aircraft operating a flight over the territory of Niger Republic must have the following documents:

- The airworthiness certificate

- The registration certificate
- The licenses of flight crew members
- The flight register called " Air Book "
- The license of airborne radio communication station
- The general declaration
- A receipt and detailed declarations of loading if it transports goods.

Non-scheduled Flights (Charters)

Non-scheduled flight operations with commercial stopovers must request authorization. Non-scheduled operators must request a flight authorization from the Ministry of Public Works, Transport and Urbanism at least 4 working days in advance of the first planned landing.

Non-scheduled operators planning a series of flight must request authorization from the Ministry of Public Works, Transport and Urbanism at least 15 days before the date of the planned first landing.

Private Flights

Private flights, of ICAO member countries, must request a flight authorization from the Ministry of Public Works, Transport and Urbanism at least 4 working days in advance.

Float Planes

The IFIM Staff is not aware of any Float Plane requirements or restrictions.

Light Sport Aircraft

The IFIM Staff is not aware of any Light Sport Aircraft requirements or restrictions.

Fees

Users should anticipate variable fees for air navigation landing, runway lighting, passenger services, overtime, parking, hangarage, fuel surcharge, passenger tax, security and Infrastructure fees. Please refer to the free on-line Niger AIP for details.

DRRN – Jet A1 and Avgas

DRZA – Jet A1 (on request)

DRZR – Jet A1 (on request)

VFR/Night VFR

The VFR flights are not allowed over and above the flight level 150.

VFR flights are not authorized at night, which means, during the period that begins 15 minutes after the sunset and finishes 15 minutes before the sunrise.

Island Hopping

The IFIM Staff is not aware of any Island Hopping requirements or restrictions.

Country Specific Travel Information

Public Health Requirements

Aircraft – The aircraft may land under the condition that it has been disinfected approximately 30 minutes before its arrival on the aerodrome. The application of this measure must be properly recorded in the Health Section of the General Declaration.

If, in special circumstances, the public health authorities find it necessary a second spraying of the aircraft on the ground, passengers and crew are permitted to disembark beforehand.

Pets

Vaccination certificates and sanitary documents are required in respect to the shipment of animals and some plants. For the security of passengers and baggage, the big animals must be transported in special cages and subject to a tranquillizing before embarking.
