Airports of Entry

OTBDDoha International AirportOTHHHamad International Airport

Note: Only Runway 16L/34R at will be operational. Pilots are reminded to exercise caution not to confuse with the other non-operational Runway 16R/34L and the runway in use at Doha International Airport. Supplement 09/12 contains all of the information that was available to date.

Entry/Exit Requirements

Entry and exit requirements are for aircraft departing the United States non-stop to country of destination. These requirements do not include any technical stops. Please refer to **Technical Stop** section in **Additional Flight Information** for the country at which the technical stop will be made.

Entry and Exit documentation forms vary from country to country. In general, however, ICAO member countries will accept the following standard ICAO Annex 9 Entry/Exit documents:

- → General Declaration
- → Passenger Manifest
- → Cargo Manifest
- → Embarkation/Disembarkation Card
- Certificate of Residual Disinsection

Examples of these documents can be found at General Information>International Flying Overview> ICAO Annex 9 Entry/Exit Documents">ICAO Annex 9 Entry/Exit Documents. The acceptance of these ICAO documents must be confirmed by the appropriate AIS.

Entry Requirements (Departing the U.S.)

- → File an eAPIS manifest outbound (recommend inbound at this time, too)
- → File and activate international flight plan
- → Land at a designated airport of entry (AOE) customs and immigration

Operators must declare upon applying for clearance that the aircraft is not carrying military cargo / photographic instrument /electronic surveillance monitoring system etc.

The following entry documents are required:

Passengers -

Valid passport

Visa

Yellow Fever vaccination certificate is required from travelers over one year of age coming from infected areas

Pilots – Same as passengers

Note: Other pilot/crewmember requirements may be applicable in lieu of those stated. Contact appropriate AIS for further clarification prior to flight.

Aircraft -

- 3 General Declarations (1 for Immigration, 1 for Health, 1 for Customs)
- 3 Passenger Manifests (1 for Immigration, 1 for Health, 1 for Customs)
- 2 Cargo Manifests (1 for Health, 1 for Customs)

Exit Requirements (Departing Qatar)

- → Same Aircraft documentation as required for arrival (see Aircraft- above)
- → Depart from an AOE
- → File eAPIS manifest if inbound to the U.S.

- → File an international flight plan
- → Call U.S. Customs at filed U.S. airport of entry

Additional Flight Information

Aircraft Instruments and Equipment

U.S. aircraft airworthiness and certification requirements may not meet other countries requirements. It is the responsibility of the pilot to determine if the aircraft meet those requirements.

The items listed below are for pilots' reference to determine if the aircraft meets minimum instrument and equipment requirements of the destination country. Additional equipment may be required to comply with the airspace navigation requirements.

VHF RTF with appropriate frequencies available

In Control Areas and Control Zones – VOR receiver and ADF receiver (75 mhz) DME

ILS

Mode A - 4096 Codes and Mode C

ACAS II for fixed wing turbine aircraft with a maximum take-off mass in excess of 5,700 kg or approved seating of more than 19

RVSM

<u>Domestic and International RVSM</u> guidance is provided on the IFIM Home Page. Click on the **Air Traffic** tab and select **Separation Standards** from the drop down list.

Technical Stop / Overflight

Non-scheduled:

Operators intending to carry out a non-scheduled flight into the territory of the State of in transit across, or making non-traffic stops in the territory of the State of Qatar, it must obtain relevant overflying / landing permission of the State of Qatar from:

Before the concerned flight is commenced for the permission to carry out such operations, at least seventy-two hours (72 HRS) notice must be given before the intended time of departure.

A flight plan shall be transmitted to ensure receipt by ATC authorities at DOHA a minimum of 2 hours prior to departure from the airport of origin.

Private: see Private Flights below

Non-scheduled Flights (Charters)

Operators intending to carry out a non-scheduled flight into the territory of the State of Qatar for the purpose of taking on or discharging passengers, cargo or mail must obtain relevant permission for the State of QATAR from the Chairman, Civil Aviation Authority (see Designated Authorities)

Before the concerned flight is commenced for the permission to carry out such operations, at least seventy-two hours (72 Hrs) notice must be given before the intended time of departure. The applicant must include the following in the order shown below:

Name of operator

Type of aircraft and registration marks

Date and time of intended arrival and departure from Doha

Place, or places, of embarkation and/or disembarkation aboard, as the case may be, of passengers and/or freight

Purpose of flight and the number of passengers and/or nature and quantity of freight Name, address and the business of the charterer, if any

Nationality of the passengers

A flight plan shall be transmitted in sufficient time to ensure receipt by ATC authorities at Doha a minimum of:

2 hours prior departure from aerodrome of origin

1 hour prior to departure from Doha

Private Flights

If an operator intends to carry out private flight into the territory of the State of Qatar for the purpose of private operations, transit or technical stop, he must obtain relevant overflying / landing permission for the State of Qatar from the Chairman Civil Aviation Authority.

A flight plan shall be transmitted in sufficient time to ensure receipt by ATC Authority at Doha a minimum of 1 hour before the aircraft is estimated to enter the territorial airspace of QATAR.

Float Planes

Light Sport Aircraft

The IFIM Staff is not aware of any Light Sport Aircraft requirements or restrictions.

Fees

Users should anticipate varying fees for landing, storage, parking and air navigation.

Fuel

Jet A1, only, is available 24hrs at Doha and Hamad.

Night VFR

VFR flights between sunset and sunrise, or such other period between sunset and sunrise as may be prescribed by the appropriate ATS authority, shall be operated in accordance with the conditions prescribed by such authority.

VFR flights are permitted between the hours of sunset and sunrise in CLASS C, D and CLASS G airspace.

Island Hopping

The IFIM Staff is not aware of any Island Hopping requirements or restrictions.
