## Entry/Exit Requirements

Entry and exit requirements are for aircraft departing the United States non-stop to country of destination. These requirements do not include any technical stops. Please refer to **Technical Stop** section in **Additional Flight Information** for the country at which the technical stop will be made.

Entry and Exit documentation forms vary from country to country. In general, however, ICAO member countries will accept the following standard ICAO Annex 9 Entry/Exit documents:

- General Declaration
- Passenger Manifest
- Cargo Manifest
- Embarkation/Disembarkation Card
- Certificate of Residual Disinsection

Examples of these documents can be found at [/IFIM Home>General Information>International Flying Overview> ICAO Annex 9 Entry/Exit Documents](#). The acceptance of these ICAO documents must be confirmed by the appropriate AIS.

### Entry Requirements (Departing the U.S.)

- File an [eAPIS](#) manifest outbound (recommend inbound at this time, too)
- File and activate international flight plan
- Land at a designated airport of entry (AOE) – customs and immigration

The following entry documents are required:

#### *Passengers, Tanzania –*

- Valid passport
- [Visa](#) for U.S. Citizens
- All passengers, except visiting residents of East African countries, are required to complete an immigration form.

#### *Passengers, Zanzibar –*

- Valid passport
- [Visa](#) for U.S. Citizens
- All passengers are required to complete an immigration form on arrival
- All Persons except citizens of Tanzania, Kenya, Uganda, and Zambia holding valid passports or Inter-State passes are required to be in possession of valid entry permits as well as valid passports duly endorsed with necessary visa while entering Zanzibar.

#### *Pilots–*

The captain of an aircraft is required to furnish a list, signed by himself, of the names of all persons in his aircraft including crew, and such other information as may be prescribed.

Members of the crew of an aircraft, whose names are listed in the manifest are not normally required to comply with immigration regulations nor are they required to report to the immigration Officer on arrival, provided that such members of the crew will be leaving Tanzania as members of the crew of the same aircraft or an aircraft of the same company.

*Note:* Other pilot/crewmember requirements may be applicable in lieu of those stated. Contact appropriate AIS for further clarification prior to flight.

*Note:* If no passengers are embarking (disembarking and no articles are laden (unladen), Only the general Declaration need be submitted to the above authorities.

#### **Exit Requirements (Departing Tanzania)**

- ➔ Same documents as required for Entry (see Aircraft- above)
- ➔ Depart from an AOE
- ➔ File [eAPIS](#) manifest if inbound to the U.S.
- ➔ File an international flight plan
- ➔ Call U.S. Customs at filed U.S. airport of entry

### **Additional Flight Information**

#### **Aircraft Instruments and Equipment**

U.S. aircraft airworthiness and certification requirements may not meet other countries requirements. It is the responsibility of the pilot to determine if the aircraft meet those requirements.

The items listed below are for pilots' reference to determine if the aircraft meets minimum instrument and equipment requirements of the destination country. Additional equipment may be required to comply with the airspace navigation requirements.

Commercial air transport aircraft operating in Tanzania must adhere to the provision of ICAO Annex 6 - Operation of Aircraft Part 1 - International Commercial Air Transport- Airplanes, chapter 6 (Airplane Instruments, equipment and Flight Documents and Chapter 7 (Airplane Communication and Navigation Equipment).

All aircraft operating within the Dar es Salaam FIR whereby Tanzania territory is overflown must adhere to the requirements of carriage of radio and radar equipment contained in the Tanzania Civil Aviation (Instrument and Equipment) Regulations, 2006.

All aircraft must carry equipment which will enable them to maintain two way communications with the appropriate ATS unit. The minimum equipment for aircraft flying under IFR is:

- a) An automatic direction finder
- or
- b) In relation to Dar es Salaam and Kilimanjaro control zones and TMAs, a VOR.

For non-scheduled flights into Tanzania for the purpose of taking on or discharging passengers, cargo or mail, (i.e. commercial flights involving traffic rights). The application for Air Service License should be addressed to the Director General noted above.

Applications must be received not less than:

- a) 14 days for license validity of more than 7 days; or
- b) 48 hours for a license validity of less than 7 days



Applications must contain the following:

- a) Name and address of operator
- b) Type of flight
- c) Type of aircraft and registration marks
- d) Date and place of origin of flight
- e) Complete route itinerary, including dates and times (UTC)
- f) Name of Captain and number of crew
- g) Number of passengers and/or freight
- h) Whether in conformity with IATA resolution 045
- i) Name address and business of character, if any
- j) Name of local agent, if any
- k) Full details of passengers and/or freight to be uplifted or set-down in Tanzania and details of the cost of the charter

Applications received through AFTN **will not** be actioned.

Requests for permit to overfly Tanzania airspace and landing in Tanzania mainland made from MON-FRI, between 1330-0430 UTC, SAT/SUN and Public Holidays daily 24 hours service should be forwarded to: TCAA Fax: (255 22) 2844204.

Request for prior permission for landing in Tanzania Zanzibar after obtaining a Landing Permit from Tanzania Civil Aviation Authority shall be made from MON – FRI, between 0430 – 1330 UTC, SAT/SUN and Public Holidays daily 24 Hours service should be forwarded to ZAA Fax +255 24 2231 653.

- a) Name and address of operator
- b) Type of aircraft and registration marks
- c) Type of flight
- d) Date and place of origin of flight
- e) Complete route itinerary, including dates and times (UTC)
- f) Name of Captain and number of crew
- g) Number of passengers and/or freight
- h) Purpose of flight

### **Float Planes**

The IFIM Staff is not aware of any Float Plane requirements or restrictions.

### **Light Sport Aircraft**

The IFIM Staff is not aware of any Light Sport Aircraft requirements or restrictions.

### **Fees**

Users should anticipate fees for take-off, landing, security, parking, outside normal hours surcharge, and air navigation. Refer to “En-Route and Terminal Air Navigation Service Charges” contact in the designated authorities section.

### **Fuel**

Jet A-1 and Avgas are available at all airports of entry except HTBU, HTMB, HTMT, HTMU, HTNR, HTPE, HTGW and HTTG which *do not* offer any fuel.

### **VFR / Night VFR**

Unless authorized by the appropriate ATS authority, VFR flights shall not be operated above FL 145, at transonic and supersonic speeds.

VFR flights between sunset and sunrise, or such other period between sunset and sunrise as may be prescribed by the appropriate ATS authority, shall be operated in accordance with the conditions prescribed by such authority.

### **Island Hopping**

The IFIM Staff is not aware of any Island Hopping requirements or restrictions.
