Airports of Entry

HUEN - Entebbe International

Entry/Exit Requirements

Entry and exit requirements are for aircraft departing the United States non-stop to country of destination. These requirements do not include any technical stops. Please refer to **Technical Stop** section in **Additional Flight Information** for the country at which the technical stop will be made.

Entry and Exit documentation forms vary from country to country. In general, however, countries will accept the following standard ICAO Annex 9 Entry/Exit documents:

- → General Declaration
- → Passenger Manifest
- → Cargo Manifest
- → Embarkation/Disembarkation Card
- → Certificate of Residual Disinsection

Examples of these documents can be found at General Information>International Flying Overview> ICAO Annex 9 Entry/Exit Documents">ICAO Annex 9 Entry/Exit Documents. The acceptance of these ICAO documents must be confirmed by the appropriate AIS.

Entry Requirements (Departing the U.S.)

- → File an <u>eAPIS</u> manifest outbound (recommend inbound at this time, too)
- → File and activate international flight plan
- → Land at a designated airport of entry (AOE) customs and immigration

The following entry documents are required:

Passengers -

- → Valid passport (valid for 6 months beyond the date of entry)
- → Visa
- > Evidence of yellow fever vaccination
- → Evidence of polio vaccination for children under 5
- Arrival declaration card

Pilots - Same as passengers

Note: Other pilot/crewmember requirements may be applicable in lieu of those stated. Contact appropriate AIS for further clarification prior to flight.

Aircraft -

- → General Declaration 4 copies for Customs, 1 for Immigration, 1 for Health, 1 for CAA
- → Passenger manifest 6 copies for Customs, 1 for CAA (Civil Aviation Authority)

Exit Requirements (Departing Uganda))

- → Same documents as required for entry (see Aircraft above)
- → Depart from an AOE
- → File <u>eAPIS</u> manifest if inbound to the U.S.
- → File an international flight plan
- → Call U.S. Customs at filed U.S. airport of entry

Additional Flight Information

Aircraft Instruments and Equipment

U.S. aircraft airworthiness and certification requirements may not meet other countries requirements. It is the responsibility of the pilot to determine if the aircraft meet those requirements.

All aircraft operating in Uganda must adhere to the provisions of ICAO Annex 6 - operation of aircraft, part I - International Commercial Air Transport - Aeroplanes, chapter 6 (Aeroplane Instruments, Equipment and Flight documents) and chapter 7 (Aeroplane Communication and Navigation Equipment) and to all the specifications outlined in regulation 75 of the Civil Aviation (Rules of the air and Air Traffic Control) Regulations, regulation 10 of the Civil Aviation (Operation of Aircraft) Regulations and the Civil Aviation (Instruments and Equipments) Regulations, 2006.

The items listed below are for pilots' reference to determine if the aircraft meets minimum instrument and equipment requirements of the destination country. Additional equipment may be required to comply with the airspace navigation requirements.

All Flights

- → VHF radio
- → Mode C, SSR Transponder

All IFR Flights

- → ADF
- → VOR
- → ACAS II (turbine engine aircraft with MTOGW of 15,000 kg or more than 30 passengers or a MTOGW of more than 5700 kg or more than 19 passengers)

RVSM

<u>Domestic and International RVSM</u> guidance is provided on the IFIM Home Page. Click on the **Air Traffic** tab and select **Separation Standards** from the drop down list.

Technical Stop / Overflight

A valid permit is required for Technical Stops/Overflights. Permits must be received by the Managing Director of Civil Aviation Authority at least 3 hours in advance of flight. Application must be made either by letter or by paid telegram. Clearance is valid for the day of travel.

Note: It is mandatory that the permit be carried on board the aircraft.

Non-scheduled Flights (Charters)

If an operator intends to carry out a (series of) non-scheduled flight(s) in transit across or making non-traffic stops in the territory of the Republic of Uganda, he must be in possession of a valid permit to do so before departure from the preceding stop.

Note: It is mandatory that the permit be carried on board the aircraft.

Private Flights

A valid permit is required for Private flights. Permits must be received by the Managing Director of Civil Aviation Authority at least 3 hours in advance of flight. Application must be made either by letter or by paid telegram. Clearance is valid for the day of travel.

Fuel

Jet A1 and AvGas are available but in limited quantities.

VFR/Night VFR

VFR flights shall not be operated above FL150 or at night.

A Ugandan import permit is required, along with an up-to-date rabies vaccination certificate and a veterinary certificate of health issued by a USDA-approved veterinarian no more than thirty days before arrival. Travelers are advised to contact the Ugandan Embassy in the United States for specific information regarding customs requirements.
