- b. Enhanced Tactical Communications & Collaboration Terrence Meekins (FAA), Kevin Dement (Noblis), Justin Prasai (FAA, SWIFT Chair)
 - *i.* As this interface matures, will there be options for RSS, custom/tailored reporting? I guess I would add a possible API/WS that a commercial application could utilize the status/alert information.

- *ii.* (1)*FF-ICE like capability and its implication to traffic flow management and flight planning. (2) SWIM feed vs. NASA DIP, what are the differences?*
 - 1. FF-ICE is being discussed this afternoon. FF-ICE will be presented as part of the discussion with CSS-FD. This is part of the flight information discussion we'd like to continue to work.
 - SWIM Feed vs NASA DIP: NASA DIP is a consumer of SWIM services, along with having access to other open-source data. This is outside the scope of today's discussion. Please email <u>swift@faa.gov</u> and we can connect on that point.
- *iii.* Is the FAA looking for user sourced (crowd sourced) CNS or FAA digital service real-time status information to enhance the SWIFT portal offering for the community? Digital PIREPS...

- *iv.* Regarding the NESG issue reporting form, is the form a digital web form or a template users will have to manually download and submit?
 - 1. Users will have to manually download and submit the form as an attachment with their email to the SWIM. Enterprise Control Center (SECC).

2. Afternoon Session

- a. Why FMDS & CSS-FD? Daniel Johnson (FAA)
 - *i.* On slide 17, FIXM usage was displayed, when IWXXM and AIXM going to be available. and specifically when will FIXM messages reference AIXM messages?
 - 1. This discussion will be taken offline.

- *ii.* The conversation seems to be system-centric migration to more datacentricity was the reason for SWIM. Could a possible solution for the concerns expressed be to represent the data/services rather than systems? As stated, systems and programs change, the data is the key.
 - 1. In fact, it really is about the services that deliver the capabilities of the system and exposing information from those services through SWIM for consumer-side service integration.

b. FMDS Transition Strategy Overview – Daniel Johnson (FAA)

- *i.* What cyber security approach are you planning to use to ensure message integrity?

- *i.* So, will there be a GUFI at the time-of-flight creation from OAG?
 - So, there will be a linkage message that will say "new GUFI <-> UFI". All flights have a UFI, some will have GUFIs if provided by the airline
